Item 566-01 – <u>Loughboro UC (Frontenac 1836-1886)</u> – 1845, folded cover from Loughboro UC (hammer 1) rated 4½d collect to Kingston (b/s). Addressed to the Provincial Penitentiary. \$200.00



Item 566-02 – <u>Hay UC (Huron – the earliest date)</u> – 1844, folded letter from Hay paid 4½d to Goderich (b/s). The letter is signed J. Scott. This is the earliest recorded date by 4 years. \$150.00



Item 566-03 – Mc Gillivray UC (Middlesex 1836-1882) – 1845, folded letter from Mc Gillivray UC (hammer 1) rated 4½d collect to Goderich (b/s). The hammer 1 is recorded from 1847 to 1849. The letter is signed James Hodgers. \$250.00



Item 566-04 – <u>East Williamsburg UC (Dundas)</u> - 1842, business folded letter from McGill & Co. of Montreal rated 9d collect to Williamsburgh. Routed via East Williamsburg and forwarded on arrival. This postmark is recorded from 1842 to 1846. \$150.00 <u>SOLD</u>





Item  $566-05 - \underline{\text{Indiana UC (Haldimand 1841-1876)}}$  - 1848, folded cover from Indiana UC (hammer 1) rated  $4\frac{1}{2}$ d collect to Chippawa (b/s) via Canboro (b/s). This is a very scarce postmark from a short-lived Haldimand office 1841-1876. \$200.00



Item 566-06 – <u>Matilda UC (Dundas – closed in 1857)</u> – 1849, folded letter from Matilda UC paid 4½d to Cornwall (b/s). The letter is signed by George Brown and addressed to the Clerk of Peace James Pringle. A rare Dundas office, closed in 1857. \$300.00



Item 566-07 -McKillop UC (Huron - 1836-1855) - 1849, folded cover from McKillop UC paid 4%d to Goderich (b/s). A rare Huron office which was in operation from 1836 to 1855. \$350.00





Item 566-08 – By steamer on the Gaspé to Quebec route – 1857, family folded letter datelined River de Loupe June 16 1857 rated 3d collect to Garafraxa UC (Wellington, 1851-1885, the earliest recorded date JU 30 57). Carried overland to Crosspoint LC, put on board a non-contracted steamer providing services between Quebec and Pictou Nova Scotia (Quebec, Father Point, Gaspé Basin, Percé, Pasbebiac, Crosspoint, Dalhousie, Miramichi, Shediac and Pictou). Forwarded west from Quebec, carried by train Montreal to Kingston and then via Ferdue, Georgetown, Guelph to destination Garafraxa (b/s). A pretty long journey, about 900 miles. \$500.00





Item 566-09 – Flos UC to Scotland (Simcoe – 1837-1858) – 1848, Ingram family folded letter from Flos UC rated 1/2 Stg collect to Scotland (b/s). Carried by the Cunard Europa 3<sup>rd</sup> voyage from New York to Liverpool via Halifax. Flos is a very scarce Simcoe office, in operation from 1837 to 1858. The letter is datelined Madonta but can't find any reference this location. Stain both sides. \$200.00 SOLD





Item 566-10 – Thorpville UC (Wellington – the only one!) – 1857, stampless cover from Thorpville UC paid 3d paying the letter rate to Brant (b/s) via Elora (b/s). This cover was carried on the Thorp stageline that operated between Guelph, Elora and Walkerton. This office was in operation from 1856 to 1863 and this postmark is the only recorded example and discovery copy. \$750.00

John Thorp, a Guelph hotel and stage coach proprietor, hired a surveyor to lay out a small village about 5 miles north of Guelph on the Elora Road. He built a hotel there as stop on his stage coach service to Elora (then a major distribution). Althought there was virtually no interest in his village lots, he did get a post office which opened in his hotel with his son in charge. Thorp laler suffered business reversals and when his Thorpville hotel burnt down in 1863, the Post Office department moved the post office to a store in Ponsonby about 2 miles to the north.



Item  $566-11 - \underline{\text{Guelph half penny drop letter rate}} - 1855$ , stampless cover from Guelph rated ½d collect paying the drop letter rate. One of the two hammers III. \$100.00 SOLD




Item 566-12 – <u>Guelph UC (Berri 20mm broken circle)</u> – 1858, stampless cover from Guelph paid 3d to Toronto (b/s). This is the Guelph Berri hammer U.C. 20mm. Also called the hammer IV. \$75.00






Item 566-13 – Eramosa UC (Wellington – the discovery copy) – 1868, 3¢ LQ cancelled by matching Normanton UC double broken circle (1854-1874) on cover paying 3¢ letter rate to Eramosa via Owen Sound and Guelph (b/s). This Eramosa UC hammer 1 is the discovery copy and now recorded from 1867 to 1869 only. Normanton was in operation from 1854 to 1874. Light reduction at left and very scarce! \$150.00 SOLD



Item 566-14 – Hollen UC (Wellington) – 1859, stampless cover from Hollen UC paid 5 paying 5¢ letter rate to Berlin (b/s). This is the hammer 1 of Hollen Ontario, proofed MY 22 52 and recorded for use 1853-1862. Interestingly, in 1859, Jas Robertson carried the mails between Hollen and Glenallan and Stu Cornelle between Glenallan and Berlin. Both routes served 6 times per week. Docketing notes on front. A very scarce postmark. \$125.00




Item 566-15 – Massie CW (Grey – the only known example) – 1867, stampless cover from Massie CW, NO 2 67, paid 5¢ paying 5¢ letter rate to Aurora (b/s) via Owen Sound and Chatsworth (b/s). Light reduction at right. The only recorded example. \$250.00





Item 566-16 – Garrafraxa CW (spelling error and the only known example) – 1857, stampless registered cover from Garrafraxa CW (Garrafraxa for Garafraxa) paid 3 paying 3d letter rate to Toronto (b/s) with registry fee paid in cash. Routed via Ferdus and Guelph (b/s). Endorsed "Too Late". This is the only known example, no record and discovery copy of this spelling error hammer. Wellington County.\$750.00





Item 566-17 – Stoney Creek CW to England (via Montreal) – 1849, family letter on mourning paper from Stoney Creek CW rated 1/2 Stg paying the Cunard rate to England (b/s). Unusually endorsed via Montreal (b/s) and then routed south to New York. Carried by Cunard from New York on the Europa 8<sup>th</sup> voyage to Liverpool. This is the earliest recorded date for this Stoney Creek postmark hammer 1. \$200.00 SOLD



Item 566-18 – <u>Ancaster UC surveyor letter (Wentworth)</u> – 1835, surveyor folded letter, signed Samuel Smith, to Lewis Burwell Deputy Provincial Land Surveyor of Upper Canada, mailed from Ancaster UC rated 4½d to Brantford. The message relates to government road and land in the Western District. Exhibit quality! \$250.00

The mapmaker and surveyor, Lewis Burwell, was one of the most well known surveyors




Item 566-19 – Glenelg UC (Grey 1852-1864) – 1854, folded cover from Glenelg UC paid 3d to Saugeen (b/s in red) and via Owen Sound (b/s). Marked "Too Late" for the day's mail and money letter. This is the earliest recorded date for the Glenelg hammer 1. A rare office which was in operation from 1852 to 1864. This office became Latona in 1864 and closed in 1888. \$350.00






Item 566-20 – <u>East Flamboro – about two orphan girls</u> – 1850, business folded letter datelined East Flamboro SE 11 50, mailed in Waterdown paid 1/4 to Montreal. Routed via Nelson and Toronto (b/s). The letter is from D. McDougall to Edmonstone Allan & Co (the Allan Line shipping company). It relates to sailing of vessels and about taking two orphan girls to Glasgow, Scotland. It reads in part: *My wish is to have the girls entirely in the captain's charge... I would prefer it much if the vessel had some female passengers on board as the girl are hardly capable of taking care of themselves.* \$150.00




Item 566-21 – Melancthon CW registered (Dufferin) – 1873, stampless registered cover from Melancthon CW, AP 22 73, paid 3¢ to Toronto (b/s) via Flesherton and Collingwood (b/s). Registry fee paid in cash. The Melancthon CW hammer with manuscript date is recorded from 1871 to 1878. \$150.00



Item 566-22 – <u>Waterdown UC to Michigan</u> – 1857, stampless cover from Waterdown UC paid 6 paying the cross border rate to Grand Rapids Michigan. Exchange markings Canada 10 Cents and paid in red. Scarce. \$100.00




Item 566-23 – Ronaldsay CW registered (Grey 1864-1874) – 1869, stampless registered cover from Ronaldsay CW paid 3¢ to Toronto (b/s) via Collingwood (b/s) with registry fee paid in cash. Ronaldsay operated from 1864 to 1874 and this Berri hammer is recorded from 1869 to 1871 only. Reverse with small paper lost. Large Queen era. \$350.00



Item 566-24 – Mariposa UC (Victoria 1836-1856) – 1846, lawyer folded letter from Mariposa UC rated 4½d collect to Peterboro (b/s). A very scarce office from Victoria County which was in operation from 1836 to 1856. Exhibit quality. \$350.00






Item 566-25 – <u>Fitzroy Harbour CW registered (Carleton)</u> – 1864, 5¢ Beaver tied by concentric ring cancel on Montreal Transcript reply cover from Fitzroy Harbour CW paying 5¢ letter rate to Montreal with 2¢ registry fee paid in cash. Routed via Pakenham and Brockville (b/s). \$175.00





Item 566-26 – Mourning cover to Kingsey CE and to Drummondville – 1867, 5¢ Beaver tied by Montreal CE Berri duplex cancel on mourning cover paying 5¢ letter rate to Elm Free Farm, Kingsey CE (double circle b/s). Routed via Drummondville and Richmond (b/s). Then redirected to Drummondville (b/s). Interestingly, dated July 4 1867 only a few days after the Confederation. \$200.00





Item 566-27 – **5¢ Beaver – Interprovincial rate** – 1868, 5¢ Beaver (*plate flaw #89, small flaw in LL "5", 2 guide dots in LL margin*) tied by Montreal CE Berri duplex cancel on lady cover paying 5¢ Interprovincial letter rate to St. Stephen (b/s) via St. John (b/s). A late printing 1868 Beaver cover! \$200.00



Item 566-28 – <u>Allan Line Peruvian winter trip</u> – 1865, 12½¢ Victoria tied by diamond grid cancel on folded cover from Toronto CW, endorsed *Per Canadian Packet*, paying 12½¢ Allan Line letter rate to Glasgow Scotland. Carried by the Allan Line Peruvian winter trip via Portland to Liverpool. \$200.00



Item 566-29 – St. John CE - 10¢ Consort printing order 5B – 1861, 10¢ Consort (printing order 5B, 17e, dark rich purple brown) tied by Canada in arc exchange marking on cover from St. John CE paying 10¢ cross border letter rate to Illinois. Montreal transit (b/s). \$500.00



Item 566-30 – <u>House of Commons</u> – 1867, 10¢ Consort (*printing order 23C, claret*) tied by Ottawa CW Berri duplex cancel on House of Commons cover paying 10¢ cross border letter rate to Maine. Routed via Montreal (b/s). Signed by John Bolton (MP for New Brunswick). \$750.00





Item 566-31 – **5¢ UPU to Guernsey** – 1887, 3¢ SQ (2) tied by Montreal duplex cancel on cover overpaying 5¢ UPU letter rate to Guernsey (b/s). Scarce destination. Foxing here and there. Ex Averbeck. \$175.00



Item 566-32 – <u>Ste. Flavie Que struck in red (Rimouski County)</u> – 1895, 1¢ stationery card mailed from Ste Flavie (struck in red) paying 1¢ PC rate to Moncton NB. The message relates to 50 pounds of wool. Very scarce in red. \$40.00



Item 566-33 – <u>Cacouna Que (Riviere-du-Loup County)</u> – 1877, 3¢ SQ tied by Cacouna Que broken circle on cover paying 3¢ letter rate to Lennoxville (b/s). \$30.00



Item 566-34 – 10¢ double weight to Isle of Man – 1890, 5¢ SQ pair tied by Montreal duplex cancel on cover paying 10¢ double weight UPU letter rate to Isle of Man. Irish Sea, England. \$350.00






Item 566-35 – <u>Peterboro underpaid with fine to England</u> – 1877, 2¢, 3¢ SQ tied by Peterboro Ont cds on cover underpaying 10¢ double weight preferred letter rate to England. Charged 7½d representing double the prepaid rate (20¢, including a 10¢ fine), less the 5¢ prepayment, 15¢ collect converted to 7½d. Kingston transit (b/s). A real wow insufficiently paid with penalty cover. \$400.00






Item 566-36 – **20¢ double wgt UPU to Ceylon** – 1879, 2¢ (2) 5¢ (3) SQ tied by matching manucript cancel on cover from South Zorra Ont (*Oxford County*) underpaying by 1¢ 20¢ double weight UPU letter rate to Ceylon (b/s). Routed via Woodstock, Hamilton and Brindisi (one of the two routes). A very early UPU rate letter to Ceylon. \$2,000.00





Item 566-37 – Rat Portage 15¢ triple wgt to England – 1896, 5¢ SQ strip of 3 tied by Rat Portage Ont cds on Queen's Hotel c/c cover paying 15¢ triple weight UPU letter rate to England (b/s). Routed via Winnipeg (b/s). \$200.00





Item 566-38 – <u>15¢ double wgt UPU registered to England</u> – 1895, 5¢ SQ (3) tied by oval registered cancel on cover from Windsor Ont paying 15¢ double weight registered letter rate to Colchester England (b/s). Hamilton Ont transit (b/s). Entered in Liverpool via London (both markings on front). \$400.00





Item 566-39 – **25¢ quadruple wgt UPU registered to Germany** – 1893, 2¢, 3¢ (6) SQ, 5¢ RLS tied by oval registered cancel on cover from Montreal, registered blue crossed lines catching eyes, paying 25¢ quadruple weight UPU registered letter rate to Germany. London transit. Foxing and aging. A very pretty cover to Germany. Ex Lussey. \$450.00





Item 566-40 – <u>Kagawong Ont (Manitoulin)</u> – 1877, 3¢ SQ, 2¢ RLS tied by fancy cancel on cover from Kagawong Ont paying 5¢ registered letter rate to Manitowaning via Collingwood (b/s). Carried by steamer to Collingwood and then back to Manitoulin Island (7 days journey). \$175.00



Item 566-41 – <u>Kagawong Ont (Manitoulin)</u> – 1878, 2¢ RLS tied by fancy cancel on 3¢ stationery envelope from Kagawong Ont paying 5¢ registered letter rate to Manitowaning. \$150.00




Item 566-42 – <u>Kagawong Ont struck in purple (Manitoulin)</u> – 1888, 3¢ SQ tied by target cancel on cover from Kagawong Ont (all struck in purple) paying 3¢ letter rate to Toronto (b/s + carrier). Reduced at left. \$100.00



Item 566-43 – <u>Kagawong Ont (Manitoulin)</u> – 1877, 3¢ SQ tied by fancy cancel on cover from Kagawong Ont paying 3¢ letter rate to Manitowaning (b/s) via Little Current. \$125.00



Item 566-44 – 10¢ UPU registered to Belgium – 1899, 5¢ SQ, 3¢ Jubilee, 2¢ Numeral (gum toned perfs) tied by Rimouski Que cds on J.H. Courchesne General Agent cover paying 10¢ UPU registered letter rate to Belgium (b/s). Montreal and London transit (b/s). Endorsed via NY. Registry label applied in Belgium. A highly unusual franking of three different definitive series. \$375.00





Item 566-45 – <u>St. Hubert Que (Chambly)</u> – 1900, 1¢, 2¢ (3) Numeral tied by target cancel on Rennie cover from St. Hubert Que paying 7¢ registered letter rate to Toronto (b/s). Isld Pond & Montreal RPO 1 (b/s). \$50.00 <u>SOLD</u>



Item 566-46 – Rougemont Station Que (Rouville) – 1899, 2¢ Map tied by Rougemont Station Que broken circle on cover paying 2¢ letter rate to Toronto (b/s). A scarce postmark from the Richelieu region. \$50.00 SOLD





Item 566-47 – Shawenegan Junction Que – discovery copy (St-Maurice) – 1911, 5¢ Edward tied by grid cancel on cover from Shawenegan Junction Que paying 5¢ UPU letter rate to Switzerland (b/s). This is the discovery copy of this postmark and the earliest recorded date. Only 2 known examples. \$150.00 SOLD



Item 566-48 – <u>Riviere-du-Loup Blacksmith</u> – 1905, 2¢ Edward cancelled by faint grid cancel on Napoleon Dion Blacksmith advertising cover from Riviere-du-Loup Que paying 2¢ letter rate to Moncton (b/s). Fraserville. \$75.00

Rivière-du-Loup was established in 1673 as the seigneurie of Sieur Charles-Aubert de la Chesnaye. The community was incorporated as the village of Fraserville, in honour of early Scottish settler Alexander Fraser, in 1850, and became a city in 1910. The city reverted to its original name, Rivière-du-Loup, in 1919





Item 566-49 – Glenada Que to Switzerland (St. Maurice) – 1913, 5¢ Admiral tied grid cancel on mourning cover from Glenada Que (a rare St. Maurice office) paying 5¢ UPU letter rate to Switzerland (b/s). This office was opened in 1908. A real wow and seldom seen Quebec cover! \$75.00 SOLD



Item 566-50 – <u>Gravenhurst Que shortpaid to England</u> – 1922, 3¢ Admiral tied by Gravenhurst Ont duplex cancel on banking cover underpaying 4¢ Empire letter rate to England. T10 converted to 2 for 2d. \$75.00



Item 566-51 – Redvers Sask registered to U.S. – 1927, 2¢, 10¢ Admiral tied by grid cancel on cover from Redvers Sask paying 12¢ registered letter ate to Staten Island, New York (b/s). Nor. Port & M. Jaw RPO No.15 "14" RPO (b/s). \$35.00 SOLD



Item 566-52 – <u>Colourful St. Hyacinthe circular receipt</u> – 1928, 20¢, \$1 Admiral, 12¢ Historical and 12 Confederation tied by St. Hyacinthe PQ cds on circular receipt for distribution to householders (*used on the English side*) paying ½¢ for 288 circulars. Pretty and unusual. \$100.00 SOLD






Item 566-53 – <u>Birtle Manitoba to British Guiana</u> – 1920, 1¢ stationery envelope with address label mailed from Birtle Manitoba, Cartwright c/c, paying 1¢ Empire printed matter rate to British Guiana (b/s). Redirected from Georgetown to Bartica (b/s). \$100.00 SOLD





Item 566-54 – <u>Paquebot Posted at Sea Liverpool</u> – 1915, 2¢ Admiral tied by Paquebot Posted at Sea Received Liverpool cds, dated 15 MR 15, on St. John beach picture postcard, paying 2¢ Empire postcard rate to England. Mailed on board RMS passenger ship of the Allan Line which served the Montreal, Quebec City, St. John and Liverpool route. \$75.00



Item 566-55 – Montreal Iron and Bronze Work advertising – 1924, 3¢ Admiral tied by Montreal machine cancel on Robert Mitchell & Co. Ornamental Iron and Bronze Work advertising cover paying 2¢ letter rate to Toronto. \$60.00 SOLD



Item 566-56 – MR5 2¢+1¢ Wartax 12x8 single use – 1925, 2¢+1¢ Wartax MR5 perforated 12x8 tied by Thamesville Ont duplex cancel on cover paying 3¢ letter rate to Huron College, London Ontario. Very scarce and almost impossible to find. \$100.00



Item 566-57 – <u>Local DLO Hamilton double circle</u> – 1916, Christmas postcard mailed unpaid from Toronto, caught and forwarded to the Toronto Dead Letter Office with "returned to" and "returned for War Tax" handstamps. Then went to Hamilton, postage paid then and forwarded to Port Dover. \$60.00




Item 566-58 – Odd 2¢ MR2 and 3¢ Conference franking – 1918, 2¢ MR2 Wartax, 3¢ Confederation #135 tied by grid cancel on cover from Mont Rolland Que (Terrebonne County) paying 5¢ UPU letter rate to Belgium. Addressed to servicemen with the 8<sup>th</sup> Company of the Belgium Army. \$125.00





Item 566-59 – <u>Unusual Toronto auxiliary markings</u> – 1927, 2¢, 10¢ Admiral tied by Hamilton Ont cds on cover paying 12¢ registered letter rate to Toronto (b/s). Not address, examined to find return address, see other side markings, pointing finger and returned to sender. \$50.00





Item 566-60 – <u>Hamilton Cream Separator</u> – 1920, 3¢. 5¢ (2) Admiral tied by grid cancel on Petrie Manufacturing Company reply cover from Nestow Alberta paying 13¢ registered letter rate to Hamilton (b/s). North Bay & Fort William RPO (b/s). \$100.00 SOLD





Item 566-61 – <u>St. Jean PQ MOOD – registered to New Zealand</u> – 1932, 2¢, 3¢, 5¢ (2) Arch tied by smudge cancel on cover from St. Jean PQ (MOOD cancel) paying 15¢ double weight Empire registered letter rate to New Zealand. Montreal and Vancouver transit (b/s). \$100.00






Item 566-62 – Winnipeg Station F registered FECB – 1943, 3¢ (2), 10¢ War tied by Winnipeg Station F cds on Park Coin Shop Numismatic Expert c/c cover, FECB, paying 16¢ double weight registered letter rate to New York, U.S. (b/s). Examined and sealed in Winnipeg. Typewritten on face "Contents few Canada Coins, Valued less than \$1.00". \$40.00 SOLD

Interestingly, the 1943 Post Guide states that: it is prohibited to send to a country of the UPU any registered article marked on the outside with the declared value of the contents, and postmaster must therefore refuse to received articles which are so marked.





Item 566-64 – <u>Halifax Blackout FECB registered to New York</u> – 1944, 14¢ War tied by Halifax Blackout cds on YMCA servicemen cover paying 14¢ registered letter rate to New York (b/s). Examined in Halifax and passed for export. Return address P.O. Strickland F16542, Canadian Legion Barrington. A pretty East Coast Blackout registered cover! \$75.00





Item 566-65 – Saskatoon Exhibition Post Office FECB to U.S. – 1943, 4¢ War tied by Saskatoon duplex cancel on cover, reverse with Saskatoon Exhibition Post Office, paying 4¢ letter rate to Pennsylvania U.S. Examined in Saskatoon with seal tied by DSPS "E" datestamp. All the same day JUL 21 43. \$40.00 SOLD






Item 566-66 – FECB 1<sup>st</sup> printing – Censorship Clerk – 1940, 3¢ Mufti tied by Quebec machine cancel on cover paying 3¢ letter rate to New York City. Examined in accordance with the FECB regulations and re-sealed with the 1<sup>st</sup> issue label "Censorship Clerk", tied by boxed Directeur de District Postal de Québec. \$50.00 SOLD

\*\*\*\*8 different FECB re-sealing labels were printed.
20,000 sheets with **Censorship Clerk** (1<sup>st</sup> printing) early 1940.
500,000 sheets total with **Examiner** (2<sup>nd</sup> to 8<sup>th</sup> printing) mid-1940 to mid-1944.






Item 566-67 – FECB 1<sup>st</sup> printing – Censorship Clerk – 1941, 3¢ Mufti tied by North Bay machine cancel on hardware c/c cover paying 3¢ letter rate to Massachusetts. Examined in accordance with the FECB regulations and re-sealed with the 1<sup>st</sup> issue label "Censorship Clerk", tied by North Bay Superintendent. \$50.00 SOLD







It reads in part: Not understanding exactly by which the new severity of the Post Office may be, I proceed as usual, if the letters should be charged to you, I must bed you to let me know the amount I own. I have no scruple of conscience in this matter. Having a large official correspondence in five separate Governments which from my Diocese, I have nearly 50 pounds a year in postage for public correspondence. Were I saved from this permission to frank all letters of official business I would readily find myself, by declaration, bond or oath, not to dispatch or receive, directly or indirectly a single private letter for which the postage should not be paid.....\$250.00
