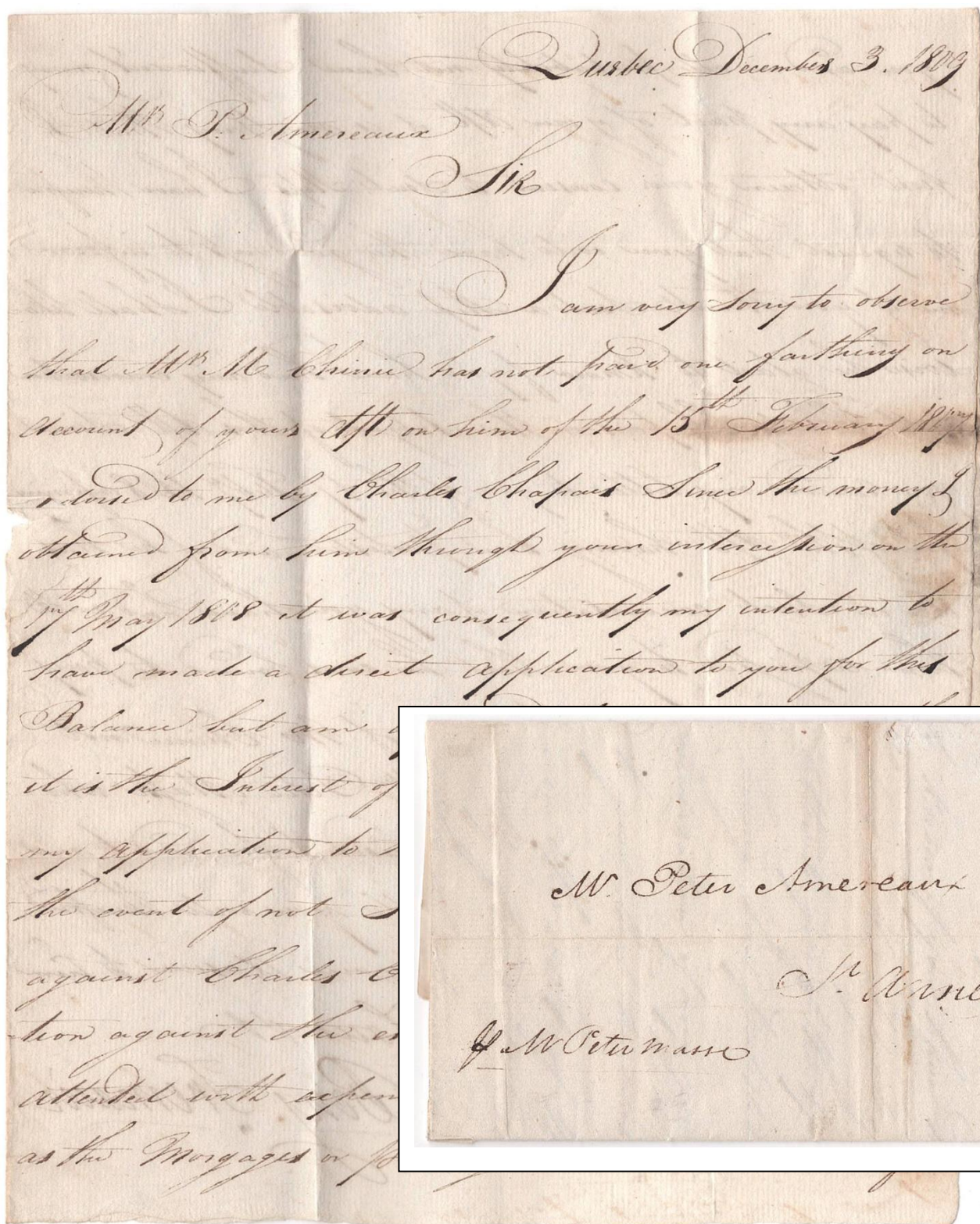

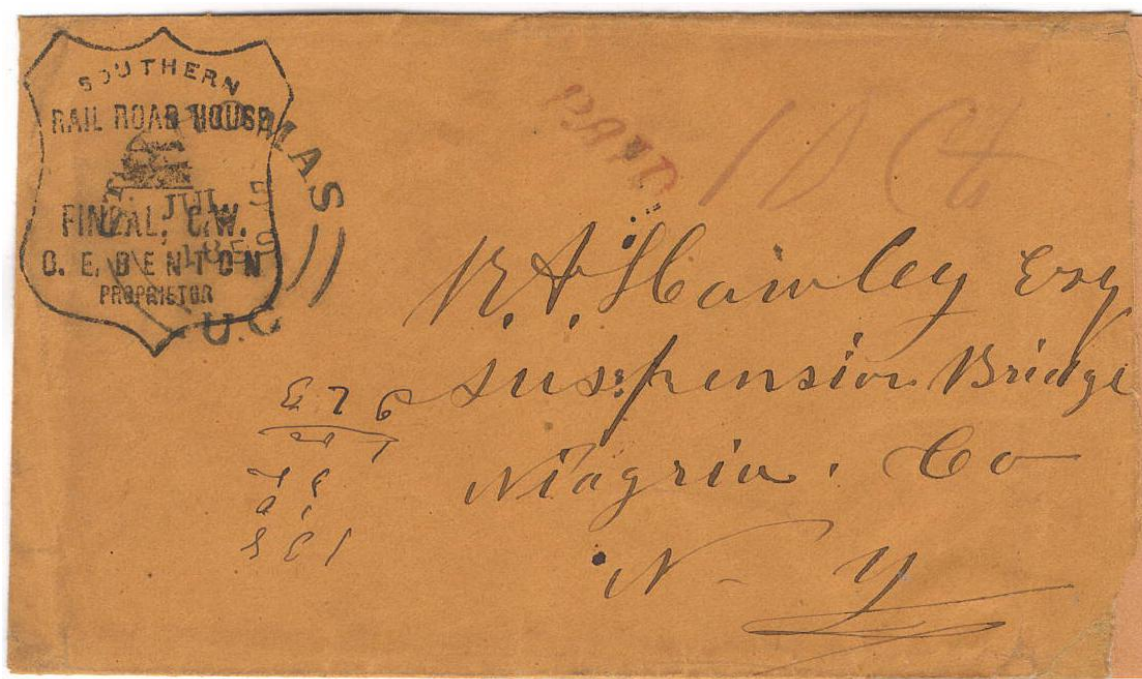




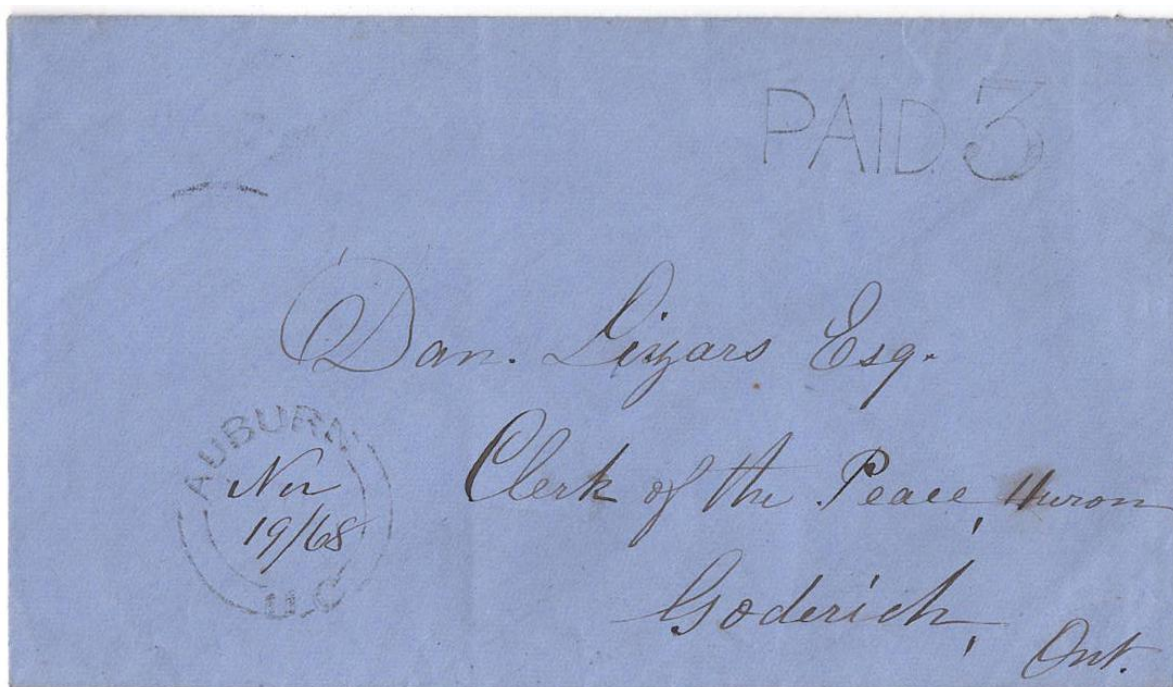
Item 650-01 – **1809 business letter Quebec to Sainte-Anne-de-la-Pérade** – 1809, business letter from Quebec merchant Benjamin Tremain to Peter Amereaux in Sainte-Anne-de-la-Pérade, carried by favour of W. Petermann. Notably predates the establishment of the post office, which opened in 1820. \$100.00



Item 650-02 – **Zone Mills UC (Lambton 1840-1856)** – 1851, stampless folded cover from Sandwich UC rated 7d collect to Euphemia via Zone Mills and Raleigh. The cover predates the establishment of a post office in Euphemia, which at the time was still part of the largely uninhabited Township of Zone. The cover features an exceptional, exhibit-quality strike from Zone Mills, arguably the finest recorded. This rare Lambton County postmark is not only in superb condition but also represents the LRD before the Zone Mills post office closed permanently in 1856. Located on the Sydenham River near Florence UC, Zone Mills likely served as a milling hub for the surrounding community. At the time of mailing, Euphemia was undergoing early settlement and development was just beginning. A rare cover, combining exceptional postal markings with early settlement context. \$400.00




Item 650-03 – **Fingal CW Southern Railroad House advertising** – 1859, stampless cover dated JY 5 59 from St. Thomas bearing advertising for the South Railroad House in Fingal, CW. Paid 10¢ paying the cross-border letter rate to Niagara, New York. O.E. Benton is listed as proprietor of the hotel in the 1857–58 Canada Directory. The establishment was likely named in anticipation of the Canada Southern Railway passing through Fingal, though the line ultimately bypassed the town by approximately 5 km to the north. Interestingly, this cover was mailed just days after Canada transitioned to decimal currency. Rough opening at right and repaired. \$150.00 **SOLD**



Item 650-04 – **Auburn UC (Huron County)** – 1868, stampless cover mailed from Auburn UC, manuscript date NO 19 68, paid 3 to Goderich (b/s). A nice little cover. \$75.00

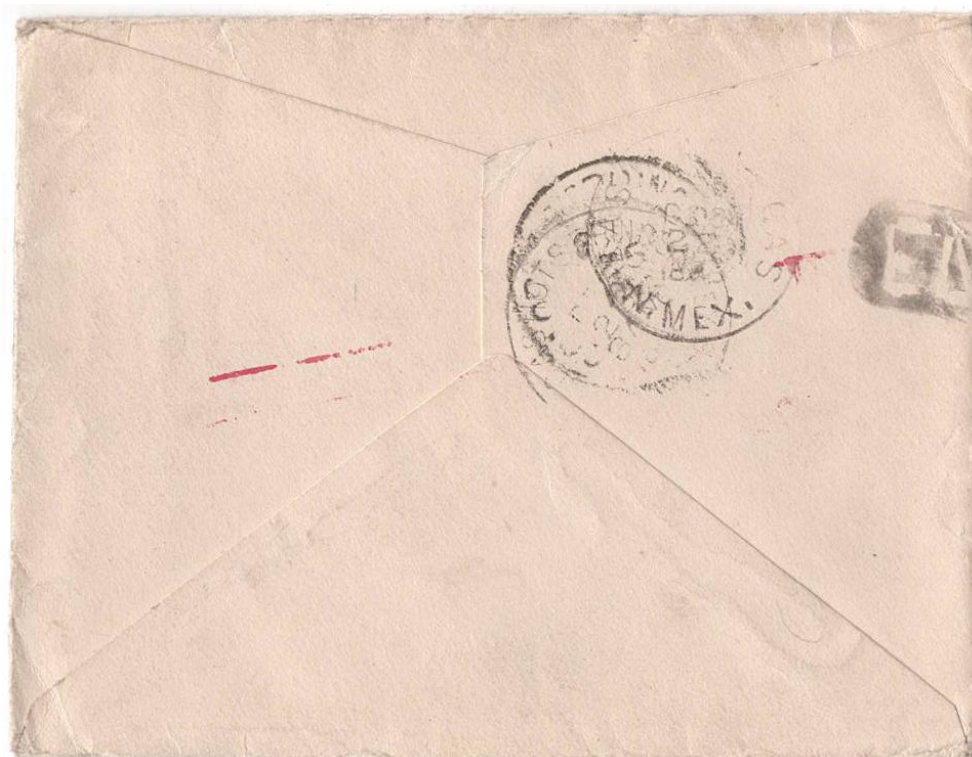

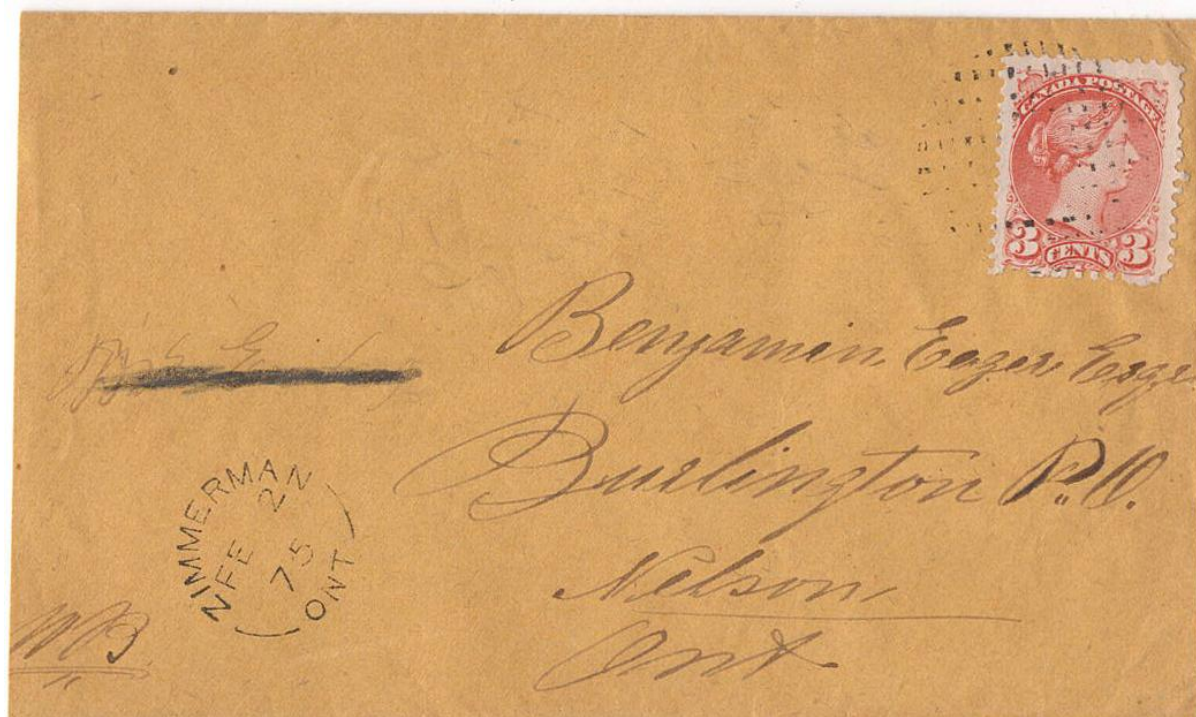

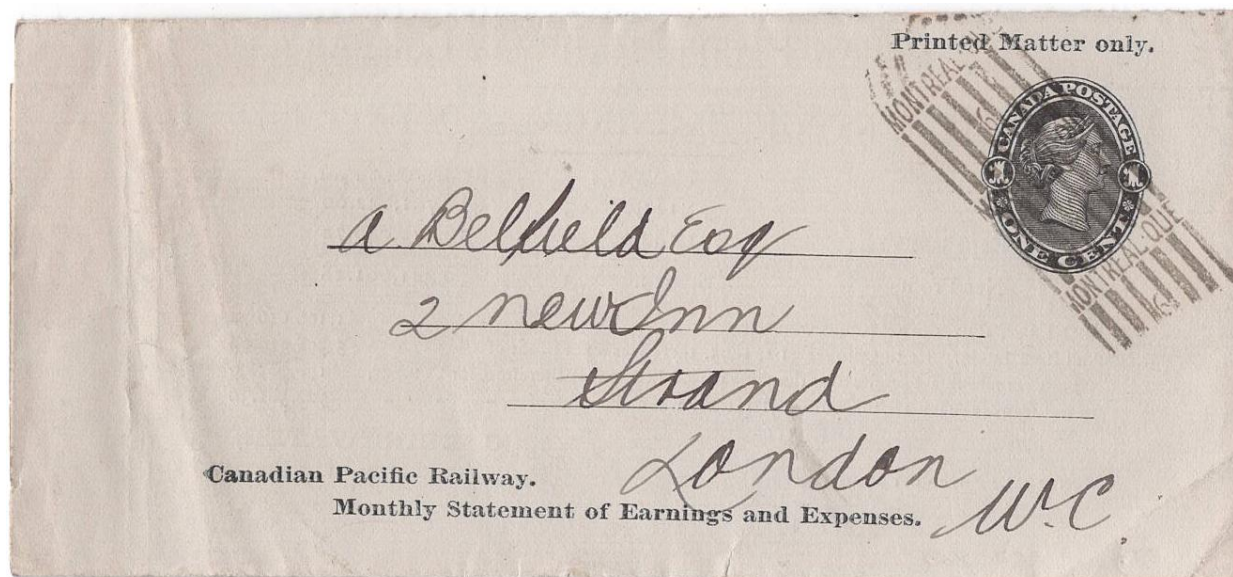

Item 650-06 – **1¢ Small Queen cover to New Mexico and Colorado** – 1888, 1¢ SQ tied by grid cancel on cover, although a general-use grid cancel, likely from Brantford Ont paying the 1¢ unsealed printed matter rate to Las Vegas Hot Springs, New Mexico (b/s). Then forwarded to Colorado Springs (b/s). Reverse bears an intaglio “EM” cancel. New Mexico became a U.S. state in 1912. \$200.00 **SOLD**



Item 650-07 – **Zimmerman Ont dotted fancy cancel** – 1875, 3¢ Small Queen tied by dotted fancy cancel on cover from Zimmerman, Ont., paying 3¢ letter rate to Nelson. A mutilated grid cancel. Slightly reduced at left. A very scarce Halton County office and distinctive fancy cancel. Zimmerman P.O. operated from 1855 to 1918. \$85.00 **SOLD**



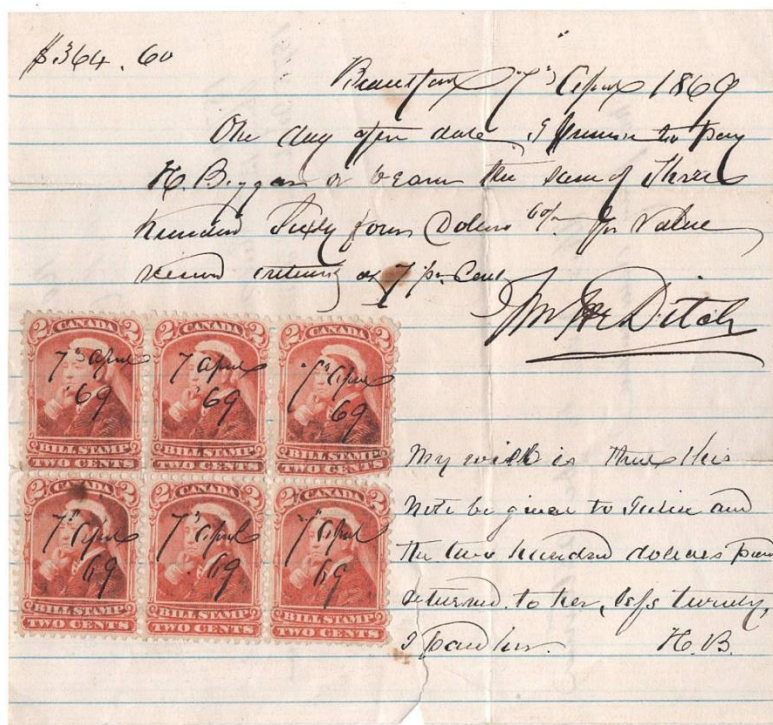
Item 650-08 – **KLS2 1¢ Rosette CPR private order letter sheet** – 1896, 1¢ Rosette on privately ordered CPR letter sheet for mailing a monthly statement of earnings and expenses from Montreal to London, England. Cancelled by Montreal roller postmark No. 6, paying the 1¢ printed matter rate. Webb KLS2 (1895–1898), p.341. While the item itself is relatively common, it bears the scarce Montreal roller No. 6, a desirable cancel for specialists. \$75.00



Item 650-09 – **Renfrew Manufacturers of Harness** – 1885, 3¢ SQ tied by concentric ring cancel on Renfrew Ont illustrated advertising cover, for R. Francis Harness and Collars, paying 3¢ letter rate to Pembroke (b/s). A visually appealing horse illustrated cover. \$125.00 **SOLD**



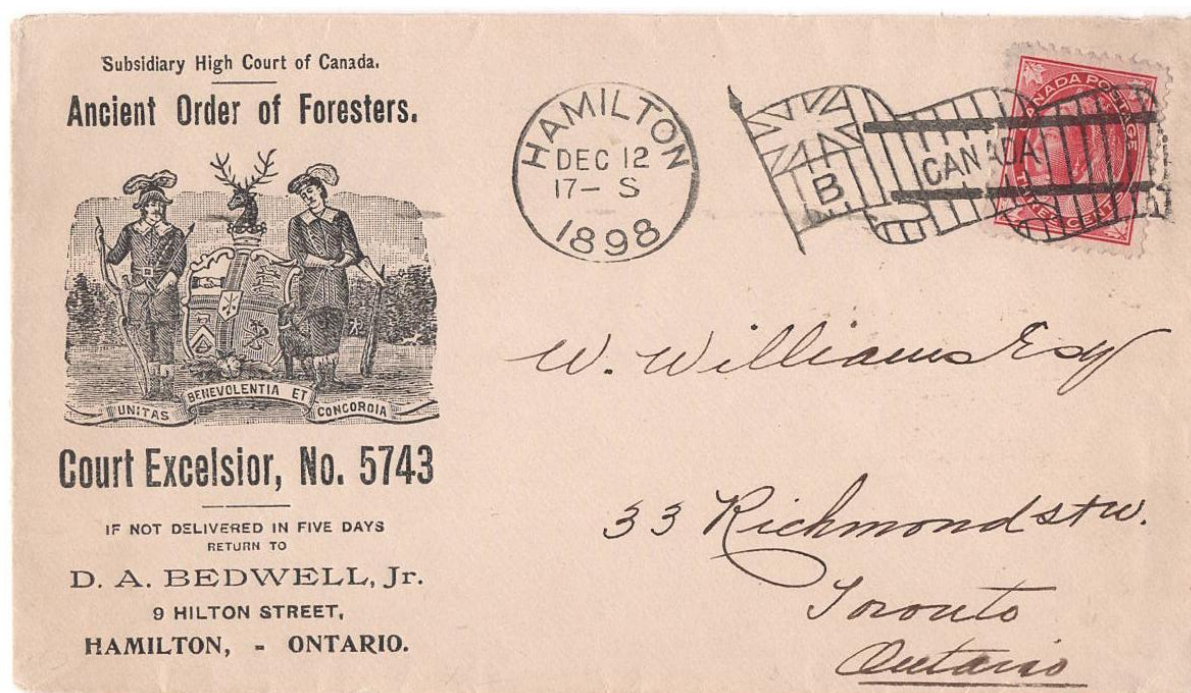
Item 650-10 – **The latest recorded Boston UC with manuscript date** – 1880, 1¢ stationery card from Boston UC, cancelled by a crisp blue fancy cancel with matching blue postmark and manuscript date, paying 1¢ postcard rate to Simcoe. This represents the latest recorded use of Boston hammer 1 (JY 6 80). In 1895, the town was briefly renamed Shawmut—a change that lasted only 16 months before reverting to Boston in 1896. Norfolk County. \$75.00



Item 650-11 – **Two Brantford Ontario promissory notes** – 1869-1876 pair of promissory notes from Brantford Ontario, each with Bill Stamps, 27¢ on the \$800 note (3¢ VD FB40, 6¢ FB43) and 12¢ on the \$364 note (2¢ VD FB39), all stamps cancelled by manuscript date. A lovely and well-matched fiscal usage pair. \$150.00 **SOLD**



Item 650-12 – **Merrickville Iron Works improper private advertising** – 1881, 1¢ stationery card from Merrickville with Kyle Mall Iron Works private advertising with dater, improperly placed on the face of the card, paying 1¢ postcard rate to Guelph. A nice example of non-compliant advertising placement. \$45.00



Item 650-13 – **3¢ Maple Leaf on fraternity advertising cover** – 1898, 3¢ Maple Leaf tied by a perfect strike of the Hamilton Bickerdike machine cancel (flag 8-2, die B) on illustrated advertising cover, for the Ancient Order of Foresters, paying 3¢ letter rate to Toronto (b/s). Advertising covers franked with the 3¢ Maple Leaf are notably scarce, as the rate was reduced to 2¢ effective January 1, 1899. \$100.00 **SOLD**



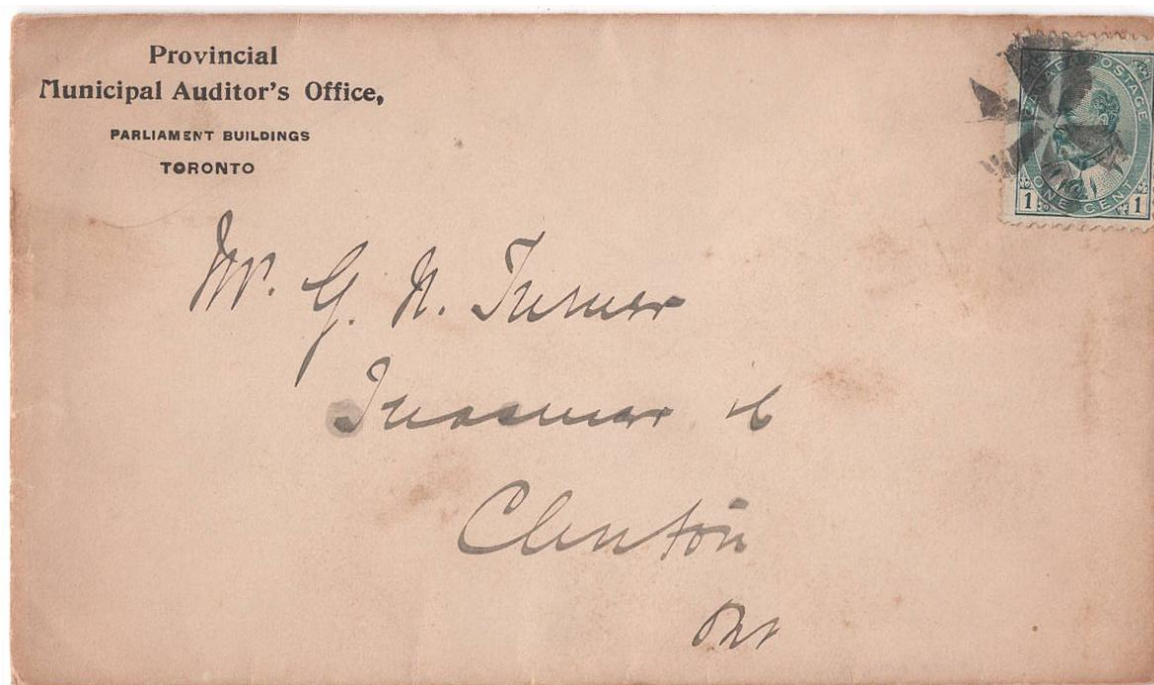
Item 650-14 – **Toronto Dominion Paper Box Company** – 1899, 2¢ Numeral tied by Toronto Bickerdike machine cancel on Dominion Paper Box Co. illustrated advertising cover (manufacturers and printers) paying 2¢ letter rate to Brockville (b/s). A nice clean cover! \$85.00



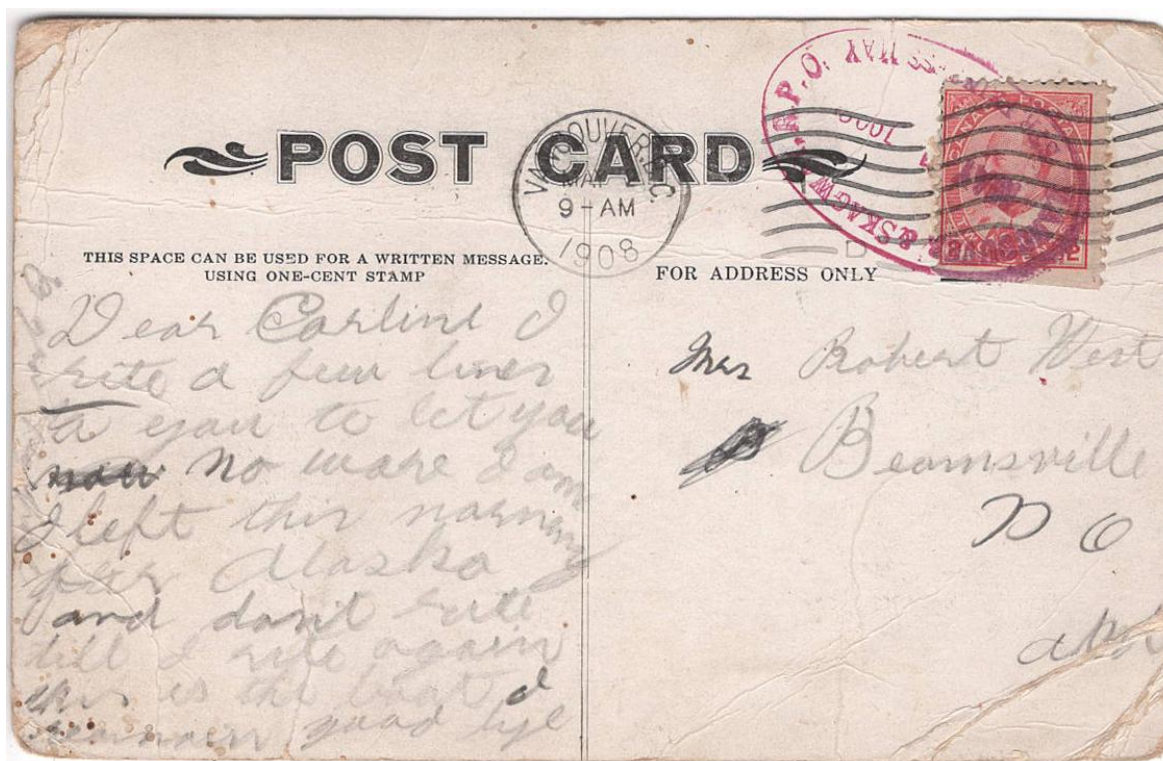
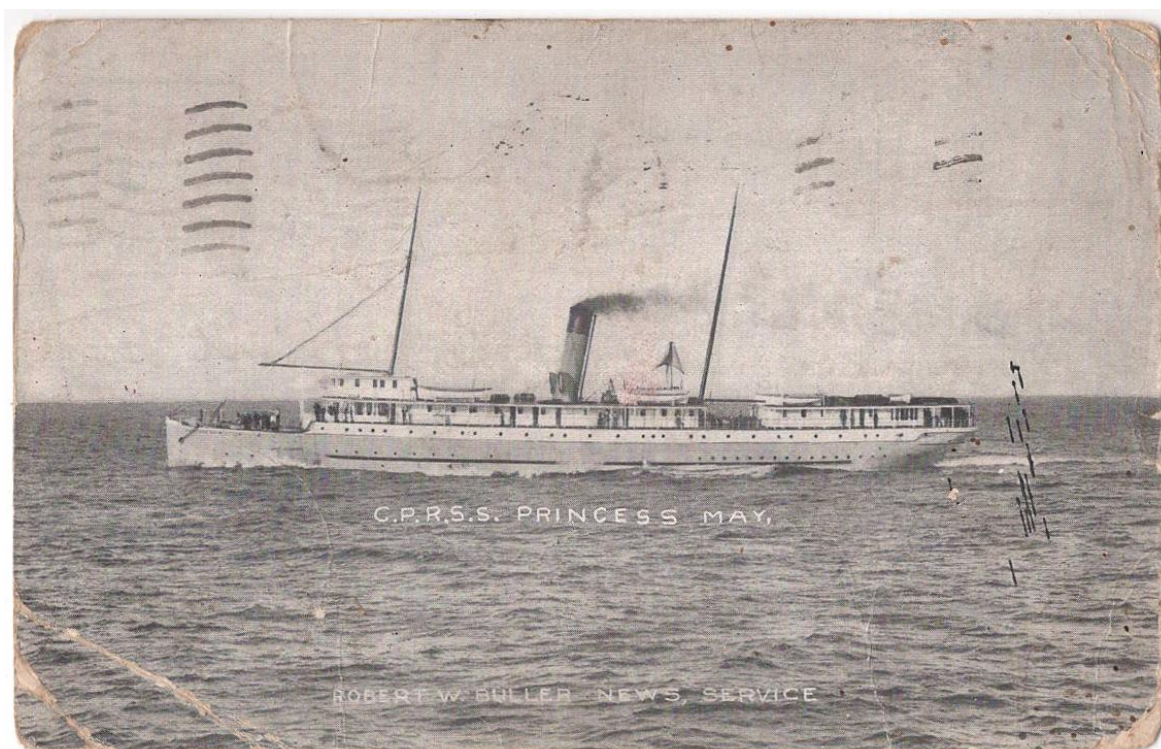
Item 650-15 – **Ottawa - The Russell Hotel** – 1899, 2¢ Numeral tied by Ottawa Bickerdike machine cancel on The Russell advertising cover paying 2¢ letter rate to Montreal (b/s + carrier mark). \$75.00 **SOLD**



Item 650-16 – **Maple Leaf Issue - 5¢ UPU to Germany** – 1898, 1¢ (2), 3¢ Maple Leaf tied by London Orb cancel on cover paying the 5¢ UPU letter rate to Germany (b/s). A very unusual and visually appealing Maple Leaf cover. \$75.00 **SOLD**



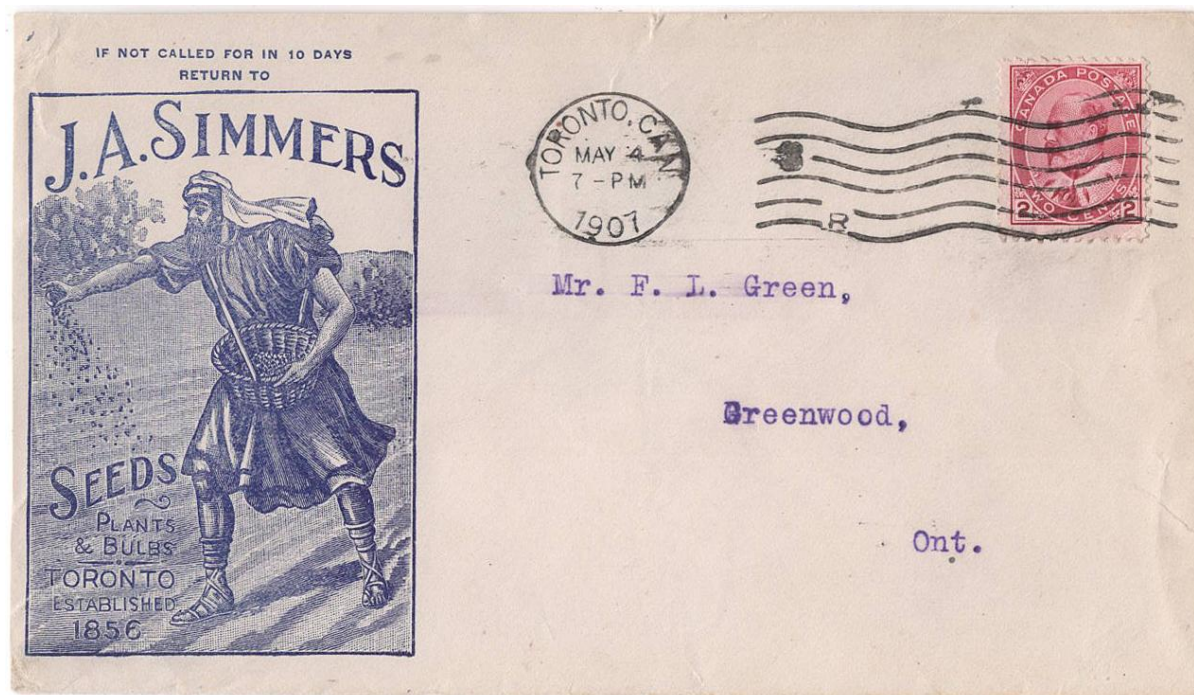
Item 650-17 – **Edwardian Era Toronto fancy** – c1905, 1¢ Edward tied by Toronto Star fancy cancel on Provincial Auditor c/c cover paying the 1¢ printed matter rate to Clinton. A charming Edwardian-era cover with a Toronto fancy. \$40.00



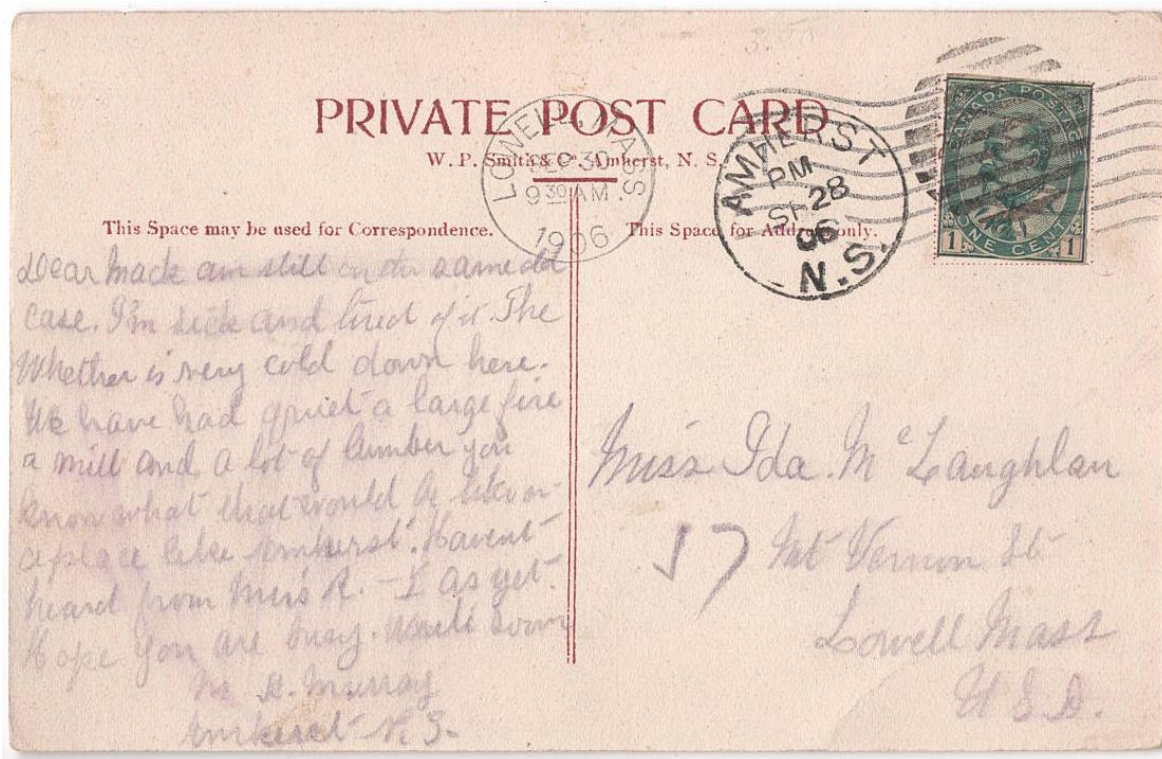
Item 650-18 – **Steamer Princess May postcard and postmark** – 1908, 2¢ Edward booklet stamp tied by oval Vancouver & Skagway RPO / Str Princess May cancel on postcard depicting the Princess May, entered the mail in Vancouver, paying 2¢ postcard rate to Beamsville Ont. A genuine maritime commercial usage. Period 1904-1912. \$125.00



Item 650-19 – **The nicest Petawawa Camp strike** – 1911, 2¢ Edward booklet stamp tied by an exceptionally fine Petawawa Camp strike on cover paying the 2¢ letter rate to Toronto. Second year of use for this military postmark with superb cancellation quality. \$60.00



Item 650-20 – **J.A. Simmers Seeds, Plants and Bulbs** – 1907, 2¢ Edward tied by Toronto machine cancel on J.A. Simmers Seeds, Plants and Bulbs illustrated advertising cover paying 3¢ letter rate to Greenwood (b/s) via Whitby (b/s). A nice Canadian horticultural advertising cover. \$50.00



Item 650-21 – **1¢ stationery cut square on postcard** – 1906, 1¢ Edward stationery cut square illegally used on postcard, tied by Amherst, N.S. duplex cancel, attempting to pay the 1¢ postcard rate to Massachusetts. The card passed through the mails and without postage due. \$40.00



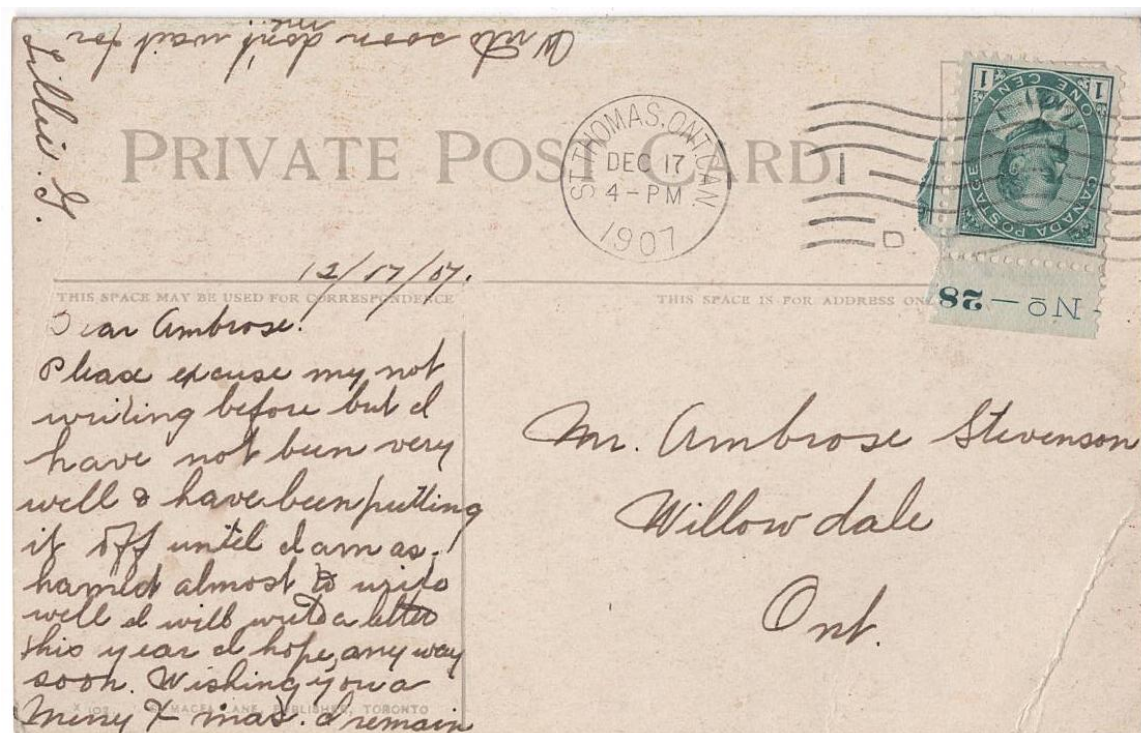
Item 650-22 – **Zealandia Saskatchewan first Post Office** – 1906, Zealandia Sask Post Office real photo postcard showing a settler posed in front of the newly established office. Written but not posted. The Zealandia Post Office was opened on April 1, 1906, with Mrs. Hodgson, sister of the town's first general store owner, serving as its inaugural postmaster. A charming pioneer-era image capturing the early spirit of Saskatchewan settlement. \$150.00



Item 650-23 – **Brandon Manitoba Merchant's Bank RPPC** – c1910. RPPC no. 1004 on AZO paper, showing the Merchant's Bank of Canada in Brandon, with Fraser & Co. Dry Goods and Clothing visible next door. Photograph by Winnipeg Photo Company of Napinka. A crisp and attractive streetscape from Manitoba's early commercial era. \$25.00 **RED**



Item 650-24 – **The scarce Local Deal Letter Office Quebec** – 1906, 1¢ Edward tied by Ottawa International machine cancel on postcard, dated NO 25 06, paying 1¢ postcard rate to L'Islet Que. For unknown reasons, the card was received at the Local Dead Letter Office in Quebec City four days later. Presumably treated as undeliverable. A scarce marking. \$125.00



Item 650-25 – **1¢ Edward with margin and plate No.28** – 1907, 1¢ Edward with margin and plate No.28 tied by St. Thomas Ont machine cancel on postcard paying 1¢ postcard rate to Willowdale. \$75.00

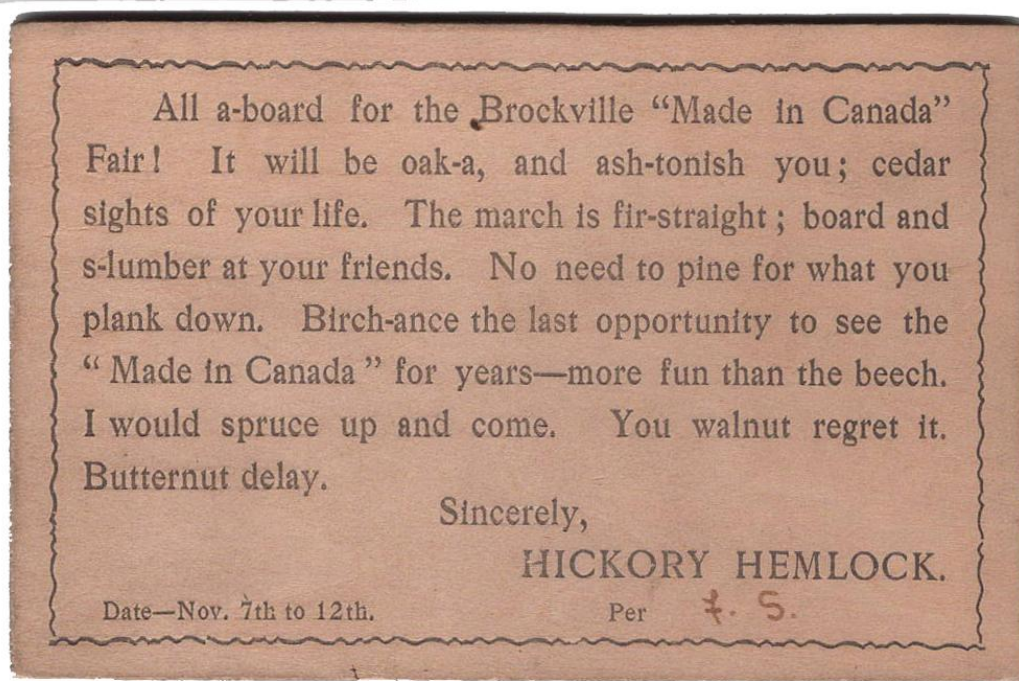

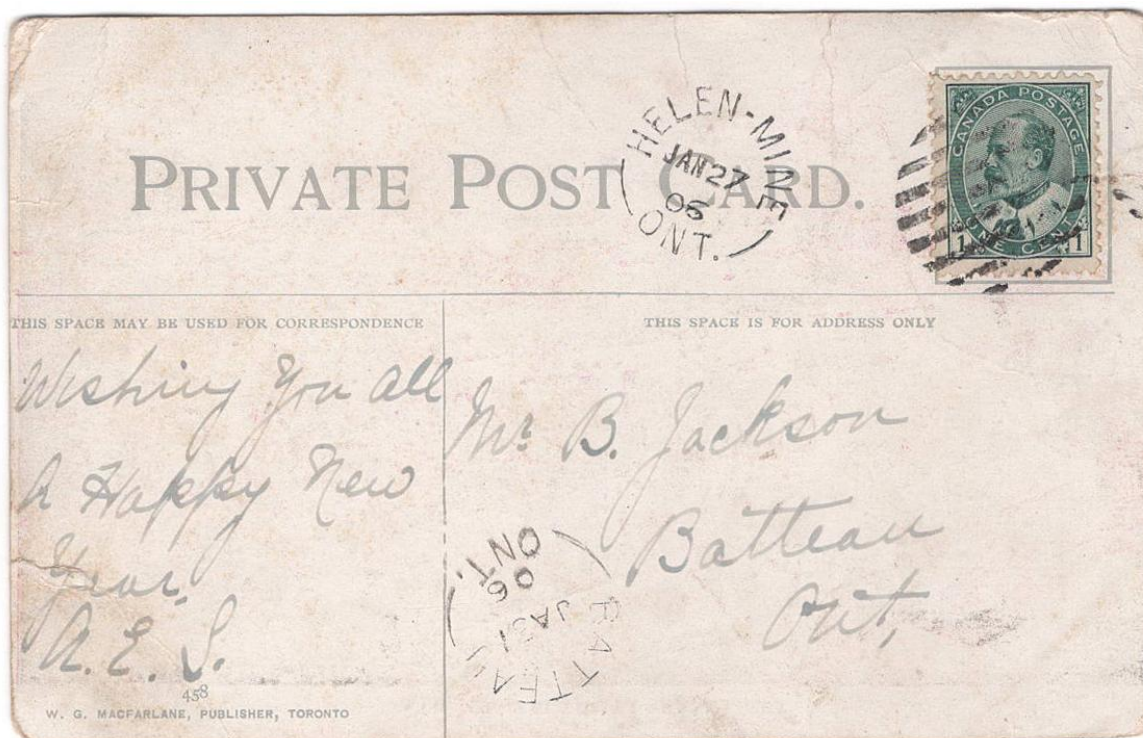


Item 650-27 – **An underpaid leather postcard use to Austria** – 1909, 2¢ Edward tied by Winnipeg & Edmonton RPO cds on striking leather postcard from Kamsask Sask, real photo attached and depicting Wild West and First Nation themes, addressed to Austria. Although leather postcards were permitted internationally, they were subject to the letter rate, not the 2¢ UPU postcard rate attempted here. As a result, the item was taxed T50 centimes the double 5¢ UPU letter rate, with no credit given for the 2¢ already paid. Converted to 10 heller postage due in Austria. A spectacular and rare example of UPU rated leather postcard usage, combining Saskatchewan appeal with postal regulation nuance. \$300.00

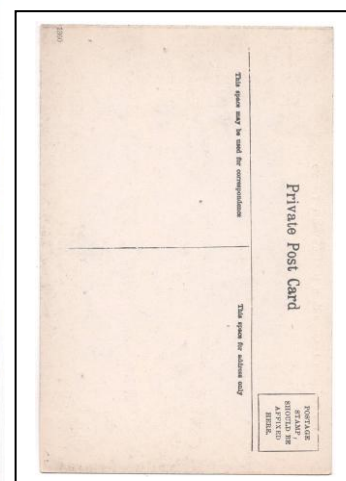

Item 650-28 – **Made in Canada Fair wooden postcard to Scotland** – 1904, 1¢ Edward (2) tied by grid cancel on wooden postcard from Lin Ontario, reverse with the Brockville "Made in Canada" Fair advertising, paying the 2¢ Empire letter rate to Scotland. Interestingly, both the Empire postcard and letter rates were 2¢ at the time, and this item passed through the mails without issue. Furthermore, postal regulations explicitly prohibited extra thick or wooden postcards, requiring them to be made of cardboard (*Postal Guide 1904 page viii and xlii: ordinary cardboard not thicker than that used by the Post Office Dept / may be posted in Canada addressed to any UPU country, must not exceed the official postal card in size*). A peculiar and non-compliant mailing that slipped through and an excellent item for the postal regulation specialist. A great item. \$150.00 **SOLD**



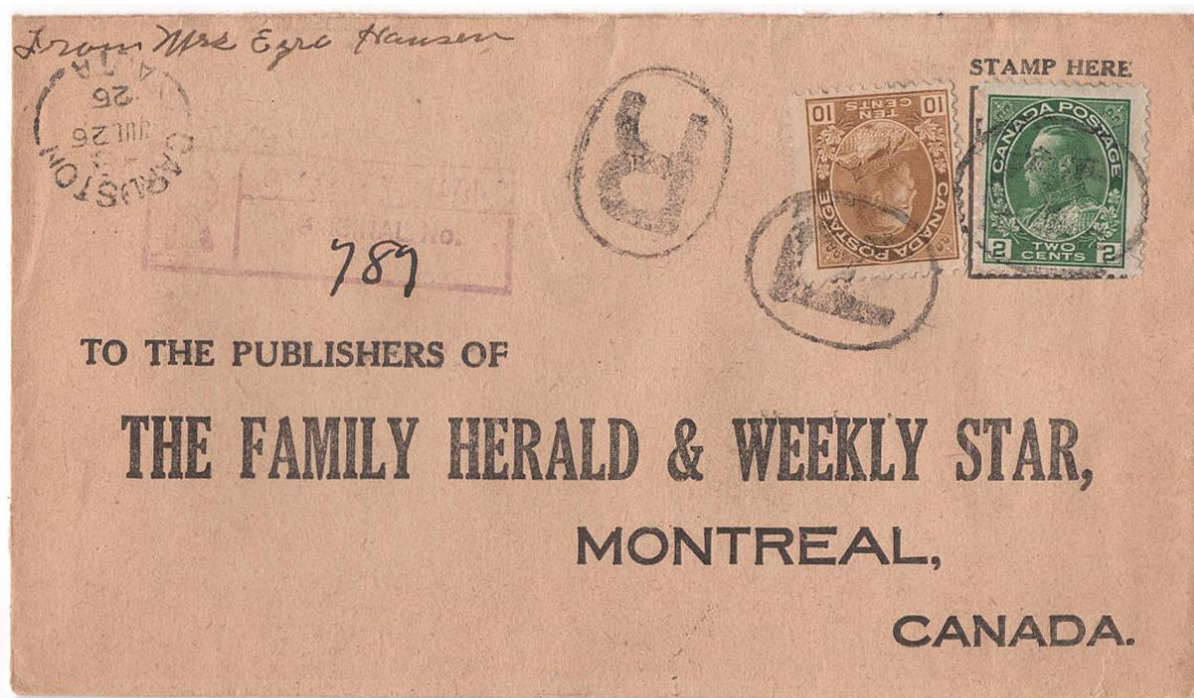
Item 650-29 – **Helen Mine Ont (Algoma – 1900-1918)** – 1906, 1¢ Edward tied by grid cancel on Winnipeg Annual Fair postcard mailed from Helen Mine, Ontario, paying the 1¢ postcard rate to Batteau. Helen Mine was a rich hematite iron site developed by Francis Hector Clergue, owner of St. Mary's Paper, and named after his sister Helen. The local post office closed permanently in 1918. \$60.00 **SOLD**



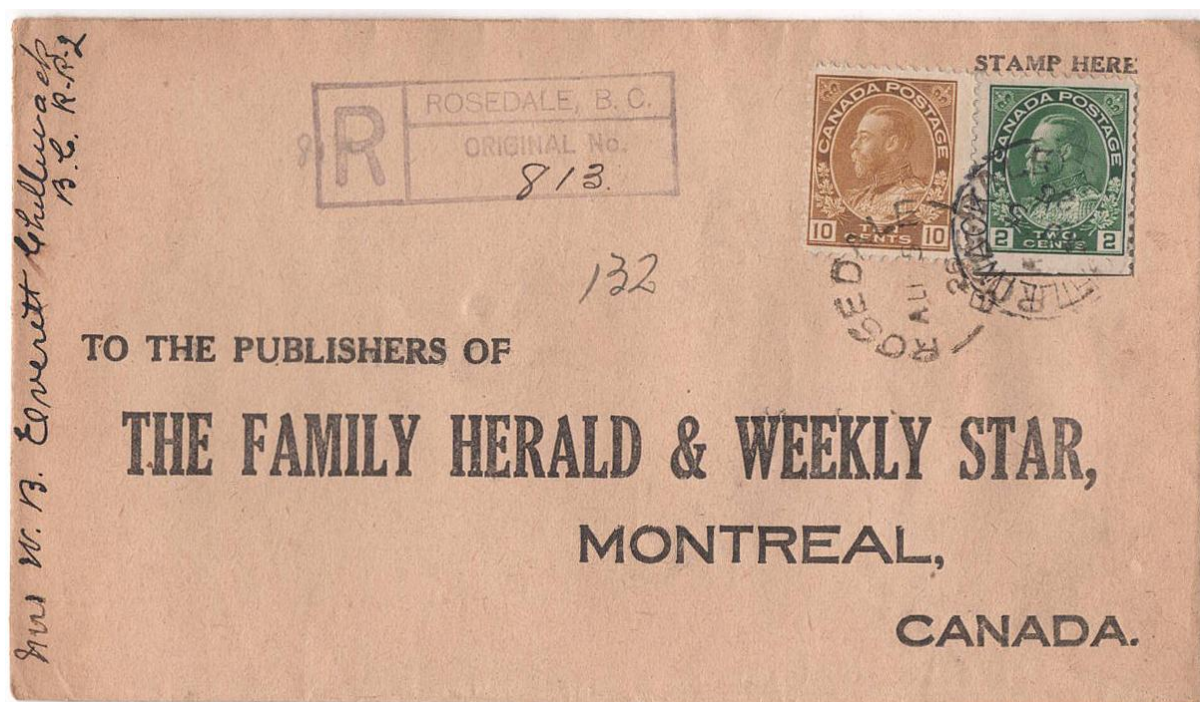
Item 650-30 – **Tecumseh Lacrosse Club picture postcard** – c1910, unused picture postcard depicting the Tecumseh Lacrosse Club at Hanlan's Point, Toronto. Unknown publisher, numbered 1360. A scarce and visually engaging sporting-themed card from the early 20th century. \$50.00



Item 650-31 – **Contemporary forged CLP2** – 1918, contemporary forged example of the 25¢ Air Club stamp (CLP2), produced circa 1918–1920. Light staining adds character, no gum. A fascinating and elusive piece for the airmail or forgery specialist. \$100.00



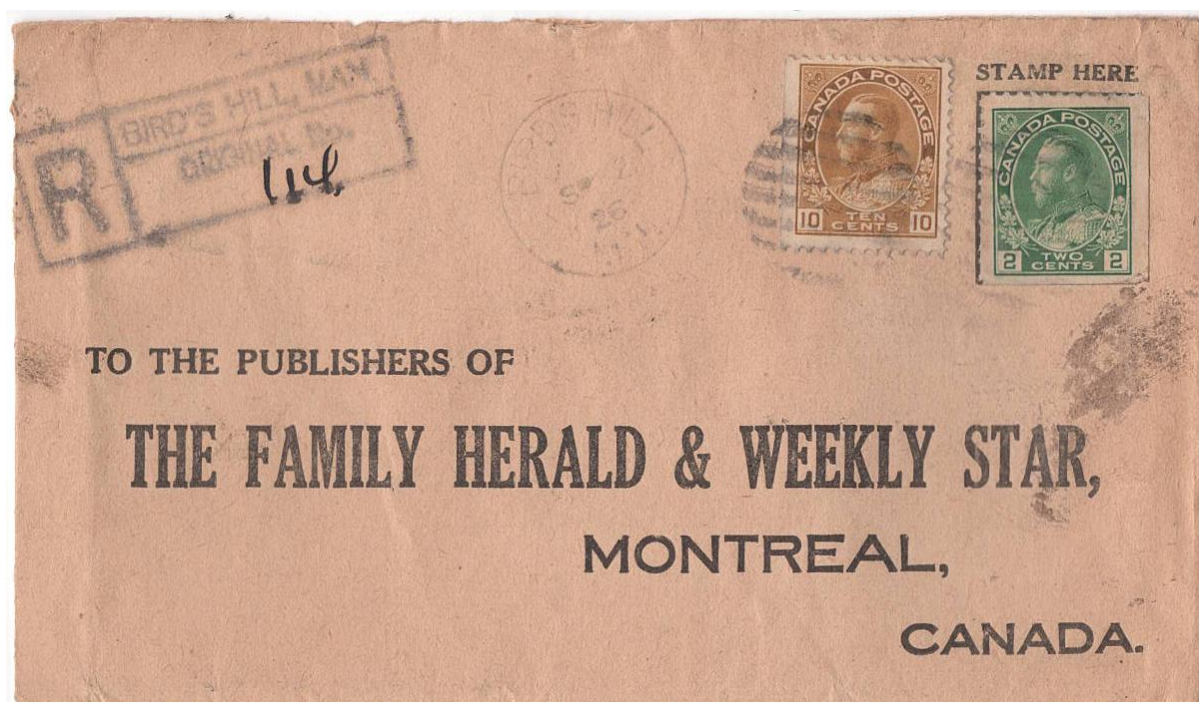

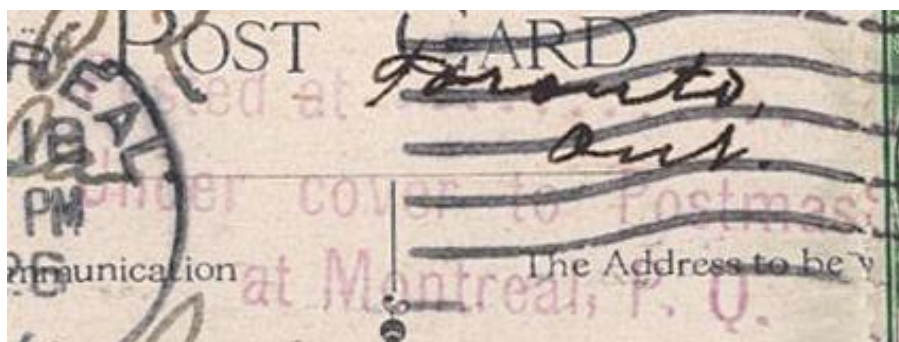
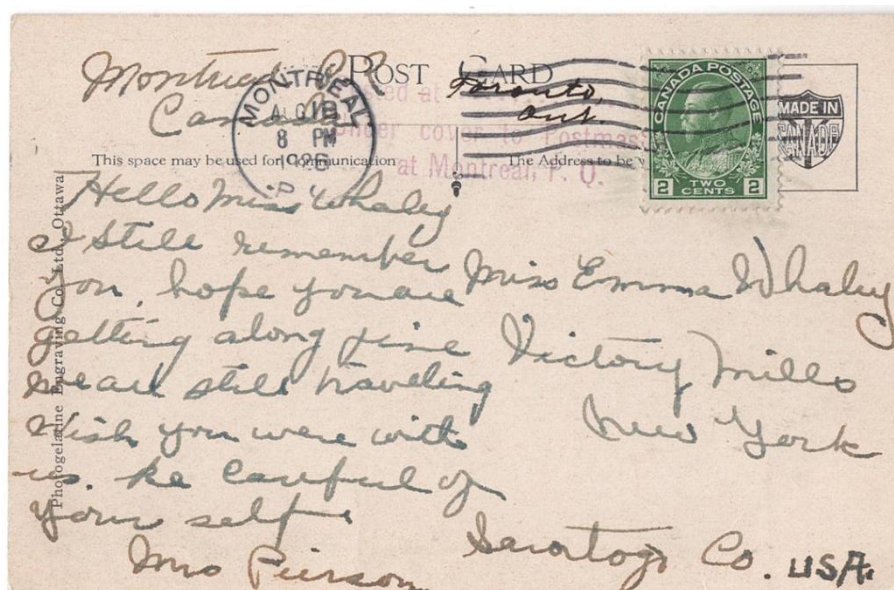
Item 650-35 – **Bird's Hill Manitoba registered** - 1926, 2¢ and 10¢ Admiral tied by grid cancel on newspaper reply cover from Bird's Hill Manitoba paying 12¢ registered letter rate to Montreal (b/s). Routed via Winnipeg and by Fort William & Winnipeg RPO (b/s). \$35.00



Item 650-36 – Vancouver BC Fraser Avenue registered - 1926, 2¢ and 10¢ Admiral tied by grid cancel on newspaper reply cover from Vancouver Fraser Ave sub office paying 12¢ registered letter rate to Montreal (b/s). Vancouver main office transit (b/s). \$50.00 **SOLD**



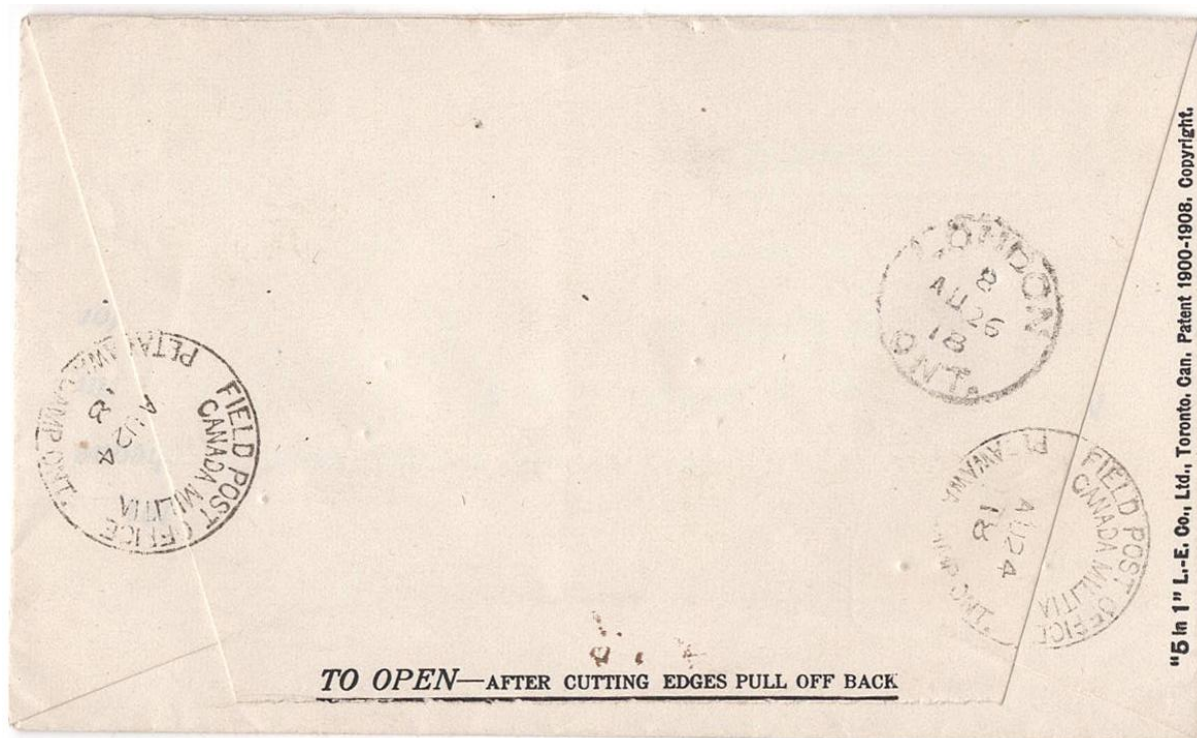
Item 650-37 – Orillia \$25.00 for \$21.50 flag cancel – 1917, 2¢ Admiral tied by the rare Orillia “\$25.00 for \$21.50” flag cancel (type 28-2), paying the 2¢ postcard rate to Sidney. Very rare and truly a “wow” item for the flag cancel enthusiast. \$200.00 **SOLD**



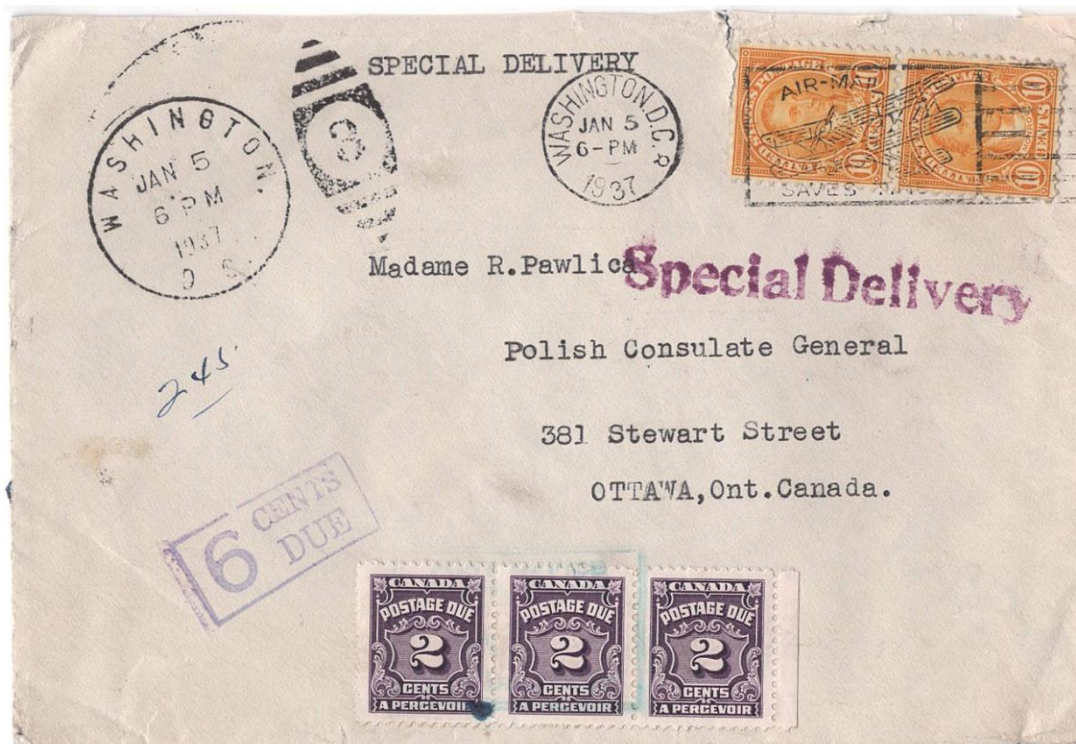
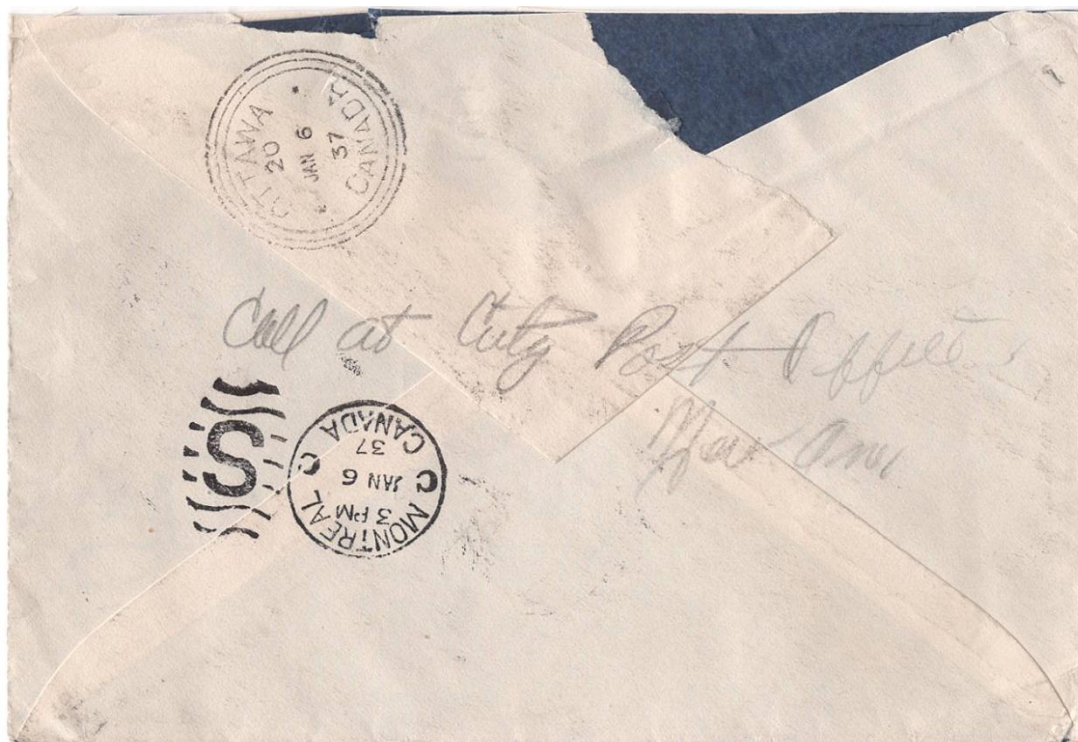
Item 650-38 – **Posted at Toronto under cover to PM at Montreal** – 1926, 2¢ Admiral tied by Montreal machine cancel on postcard paying 2¢ postcard rate to Victory Mills, New York. Presumably missent to Toronto or wrongly sorted, resulting in the seldom-seen auxiliary marking: “Posted at Toronto Ont – under cover to Postmaster at Montreal PQ.” An interesting instructional marking for the auxiliary marking specialist. \$25.00



Item 650-39 – Toronto J.H. Morin & Co. Paints and Varnishes – 1928, 1¢ Admiral tied by Toronto 3rd class machine cancel on advertising postcard for J.H. Morin & Co., Paints and Varnishes, paying the 1¢ printed matter rate to Ottawa. Tiny scuff on stamp side of card. Still a clean and visually appealing example of early Canadian paint and varnish branding through the mail. \$50.00



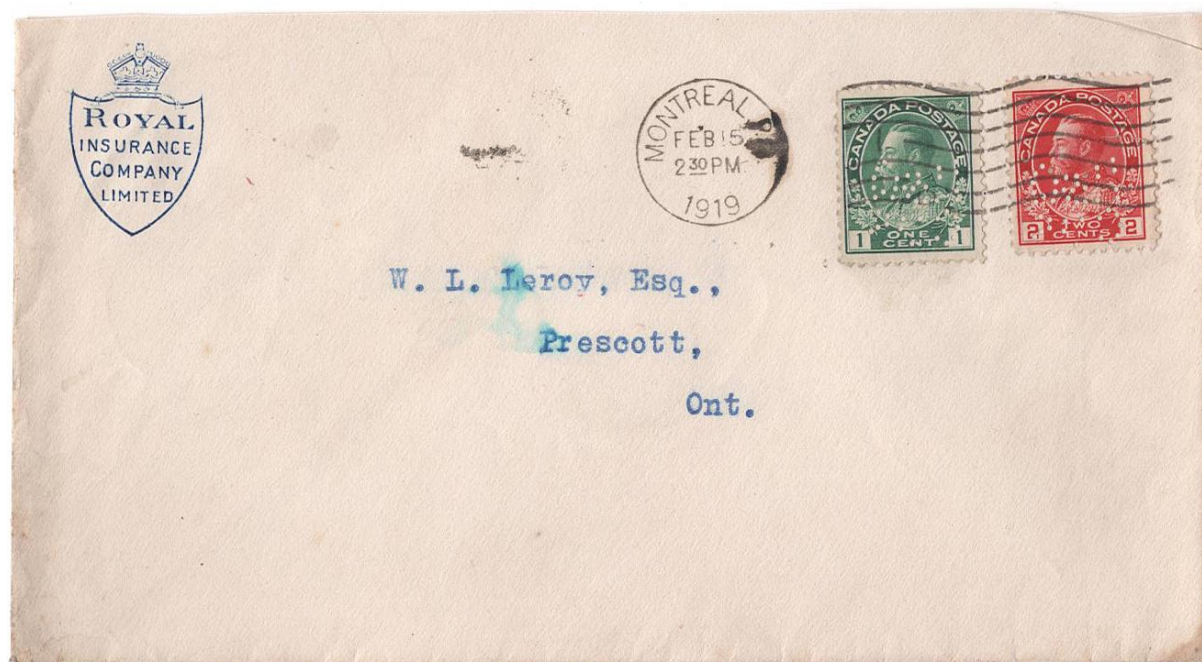
Item 650-40 – **Petawawa Camp Paymaster fold-out registered** – 1918, 1¢, 7¢ Admiral tied by FPO Canada Militia Petawawa Camp cds on OHMS MFD 901 form (*Paymaster fold-out*), paying the 8¢ registered letter rate to Byron (b/s). A very scarce and exhibit-quality military camp registered cover. \$300.00



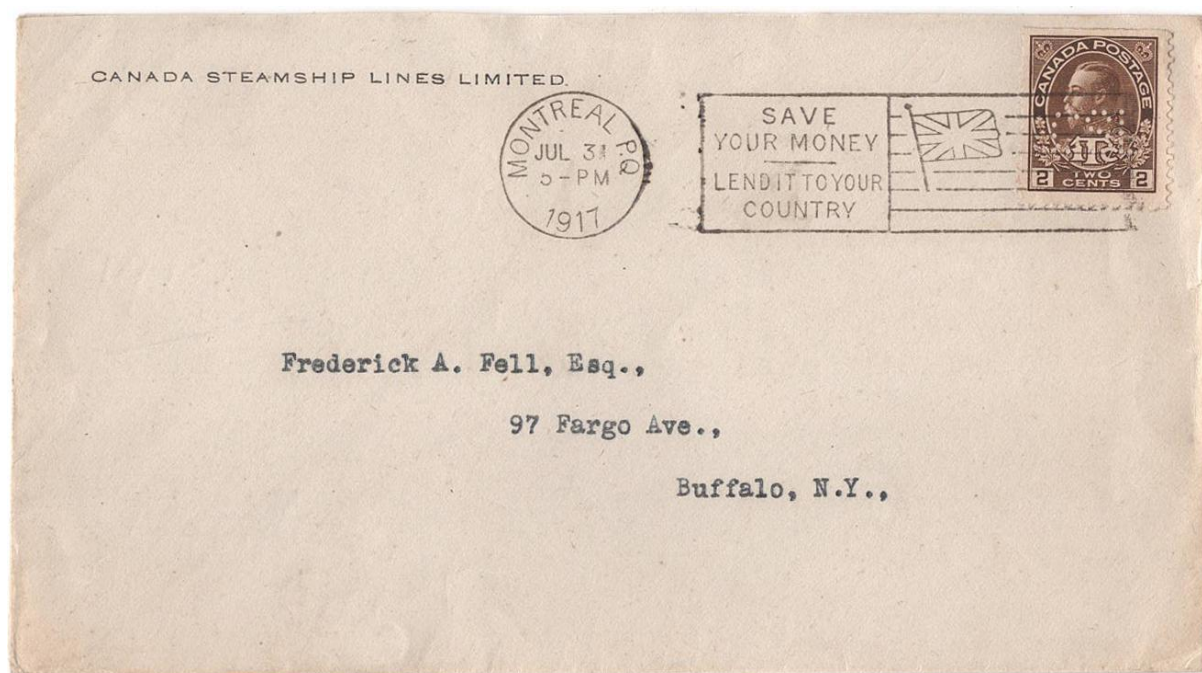
Item 650-41 – Underpaid U.S. special delivery cover to Ottawa – 1937, US 10¢ Monroe (2) tied by Washington, D.C. machine cancel on cover underpaying 23¢ special delivery letter rate to Ottawa (b/s). Assessed 6¢ postage due, routed via Montreal (b/s), with postage due paid by a strip of three 2¢ Fourth Issue stamps. Addressed to the Polish Consulate General. A very pretty special delivery cover with rate deficiency and diplomatic destination. \$75.00 **SOLD**



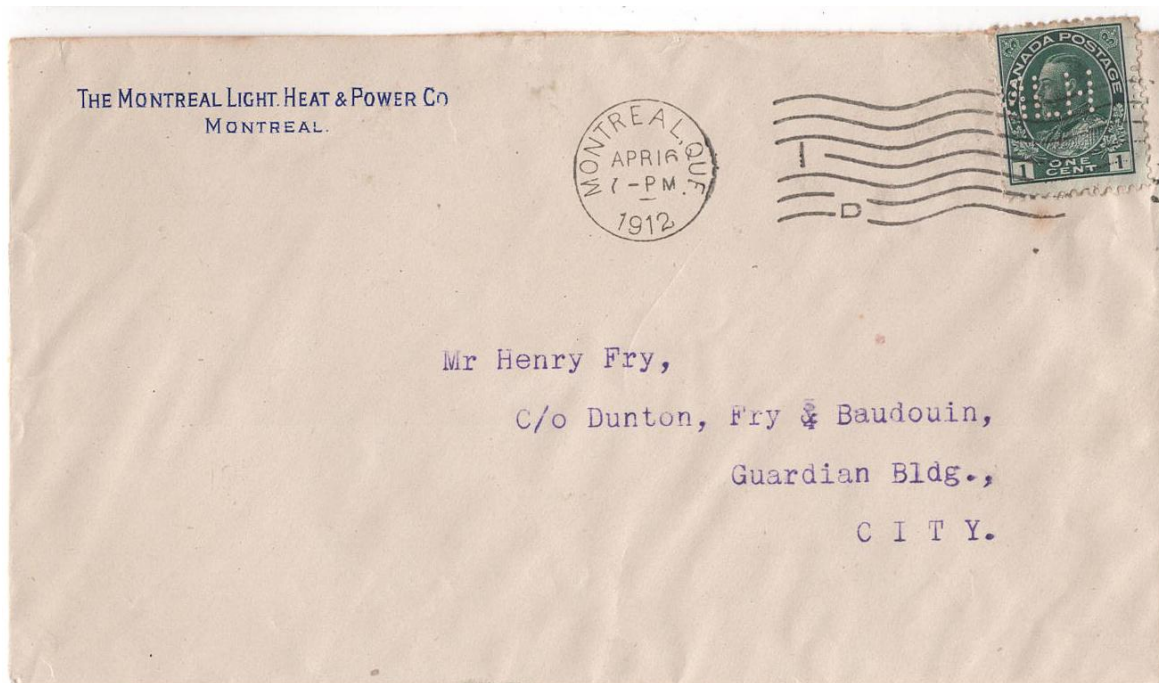
Item 650-42 – **Hand-sewn birch bark letter from Riley Brook NB** – 1917, 2¢ Admiral tied by Riley Brook, N.B. broken circle on a hand-sewn birch bark letter paying the 2¢ letter rate to West Virginia. The letter consists of two birch bark postcard-sized panels, originally blank, now written on all sides and stitched together. Along the edge, a manuscript note reads: “this was cut from tree by me” A highly unusual Admiral-era artifact, blending natural materials, personal expression, and scarce rural postal history. \$125.00 **SOLD**



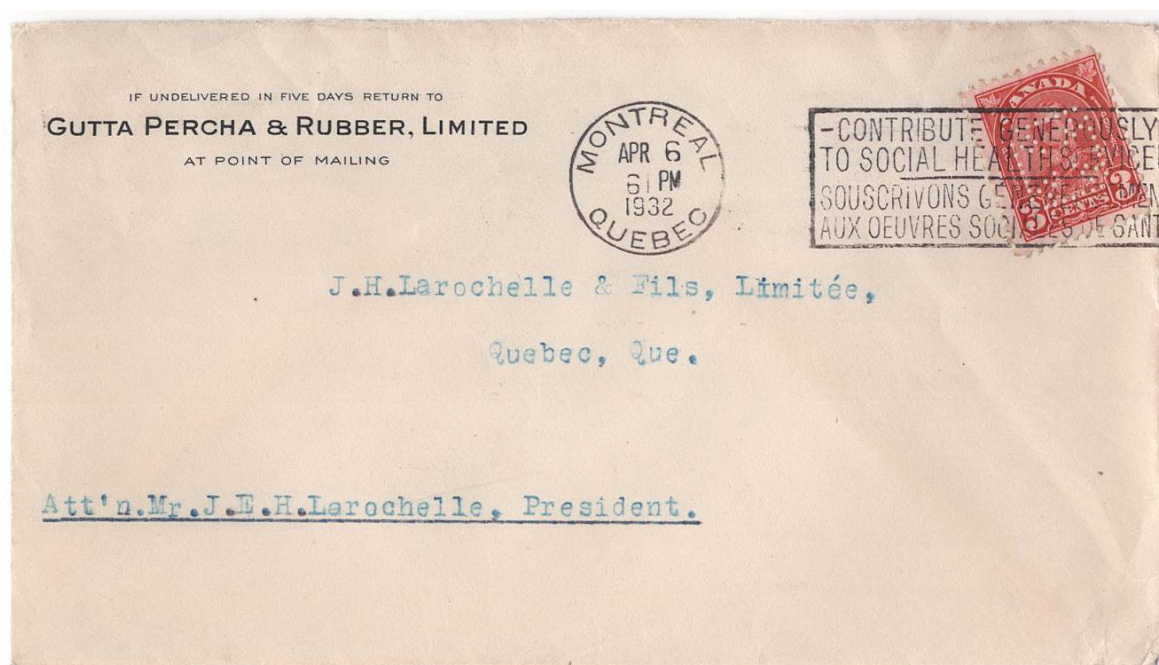

Slightly trimmed at top. Catalogued as R5, RF G. A nice cover for the perfin specialist. \$40.00



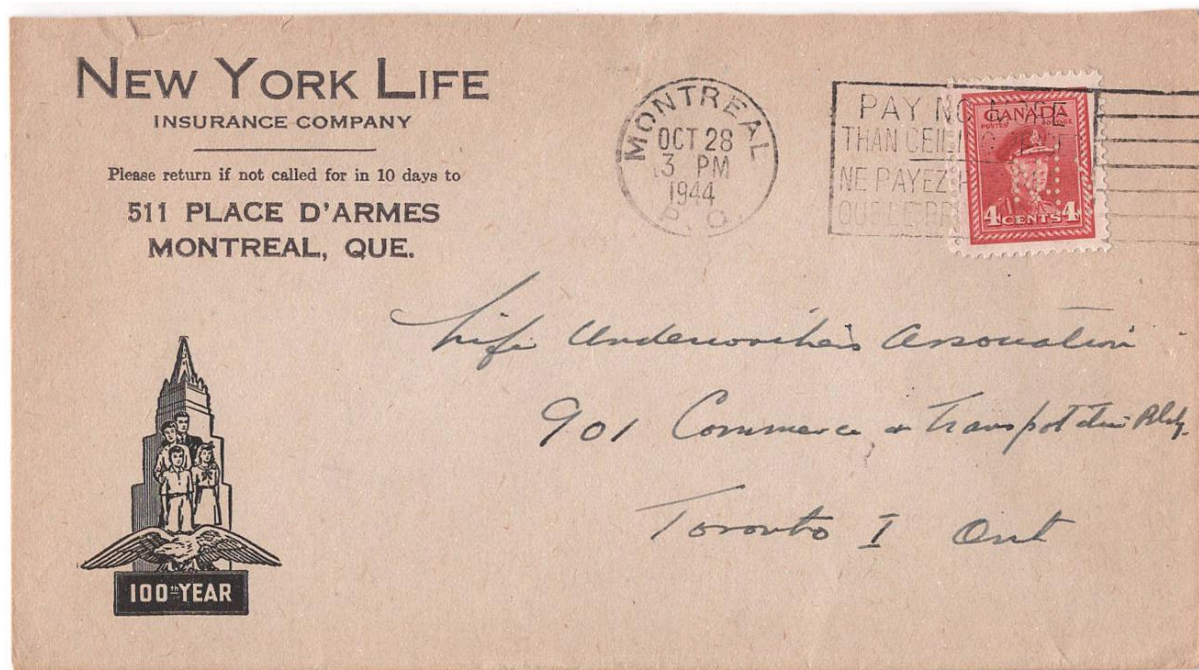
Item 650-45 – **Canada Steamship Lines Ltd perfin cover** – 1917, 2¢+1¢ Wartax stamp with CSL perfin tied by Montreal 34-4 flag cancel on Canada Steamship Lines c/c cover, paying the 3¢ letter rate to Buffalo. Catalogued as C37, RF F. A highly unusual and desirable combination of Wartax franking, commercial perfin, patriotic flag cancel, and steamship company. \$50.00 **SOLD**



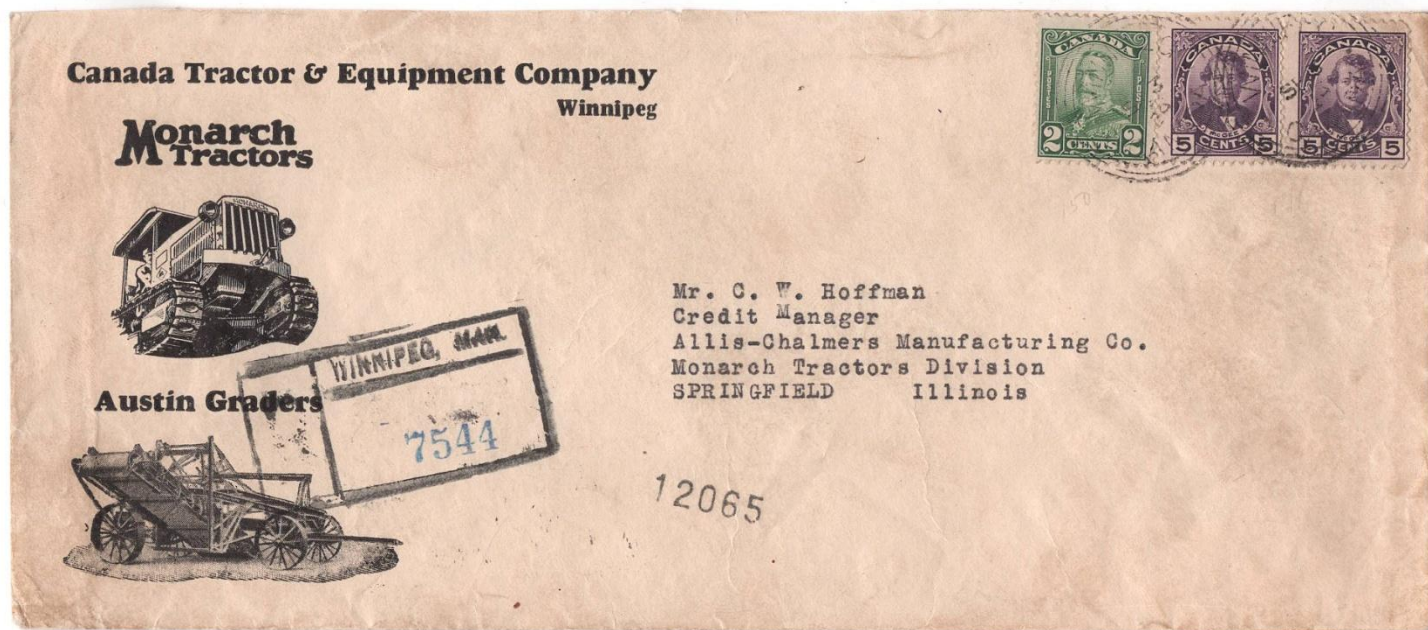
Item 650-46 – **Montreal Light Heat & Power Co. perfin cover** – 1911, 1¢ Admiral with MLH perfin tied by Montreal machine cancel on Montreal Light, Heat & Power Co. corner card cover, paying the 1¢ drop letter rate. Catalogued as M14, RF F and dated AP 16 12. Possibly a new late date of use for this perfin, surpassing the previously recorded AU 14 12. An intriguing and potentially significant update for the perfin specialist. \$75.00 **SOLD**



Item 650-47 – **Gutta Percha & Rubber perfin cover** – 1932, 3¢ Arch issue with Maltese Cross perfin tied by Montreal machine cancel on Gutta Percha & Rubber Ltd c/c cover, paying the 3¢ letter rate to Quebec City. Catalogued as #1, RF G and dated AP 6 3. Possibly a new late date of use for this perfin, extending beyond the previously recorded MR 4 32. A potentially significant update for the perfin specialist. \$60.00



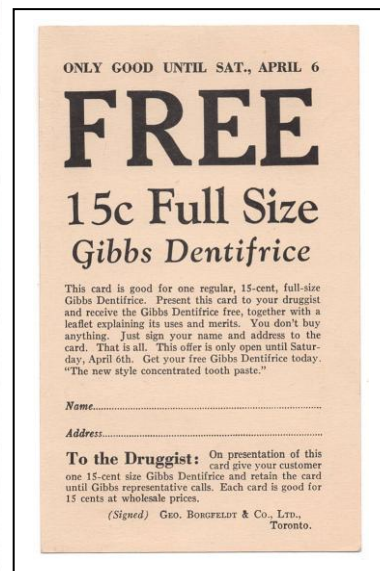
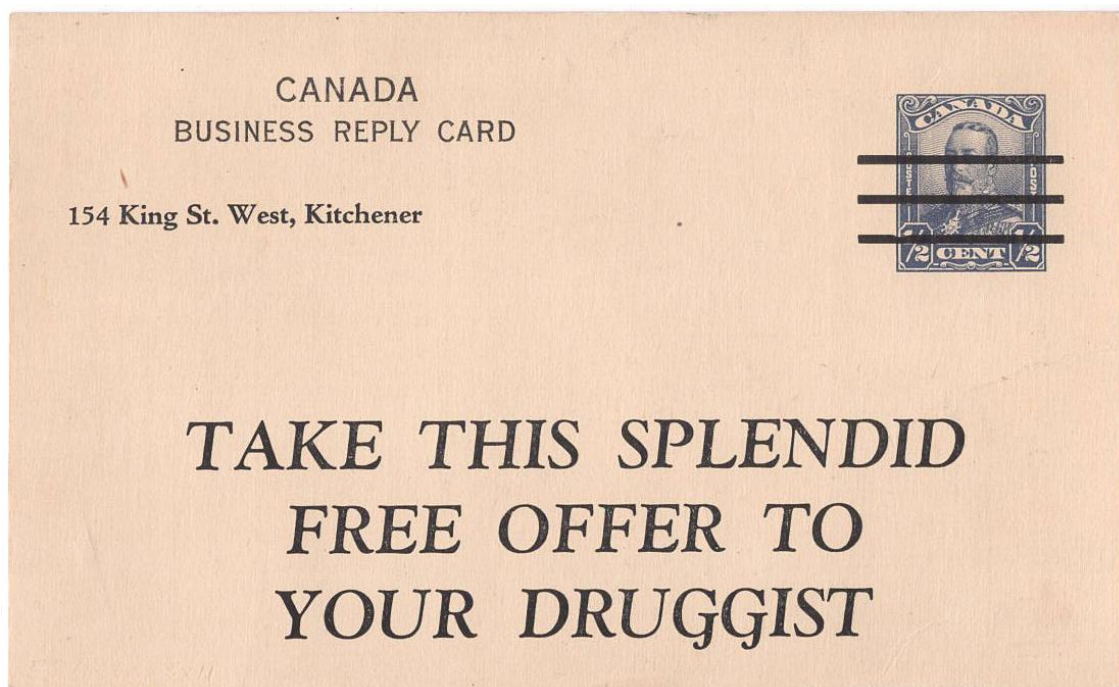
Item 650-48 – **New York Life perfin cover** – 1944, 4c War Issue with NLY perfin tied by Montreal machine cancel on illustrated New York Life Insurance 100th Anniversary cover, paying the 4c letter rate to Toronto. Dated OCT 28 44. Catalogued as N15, RF G. Cover has partial back flap off. NYL perfins are notably scarce on these commemorative covers. \$50.00



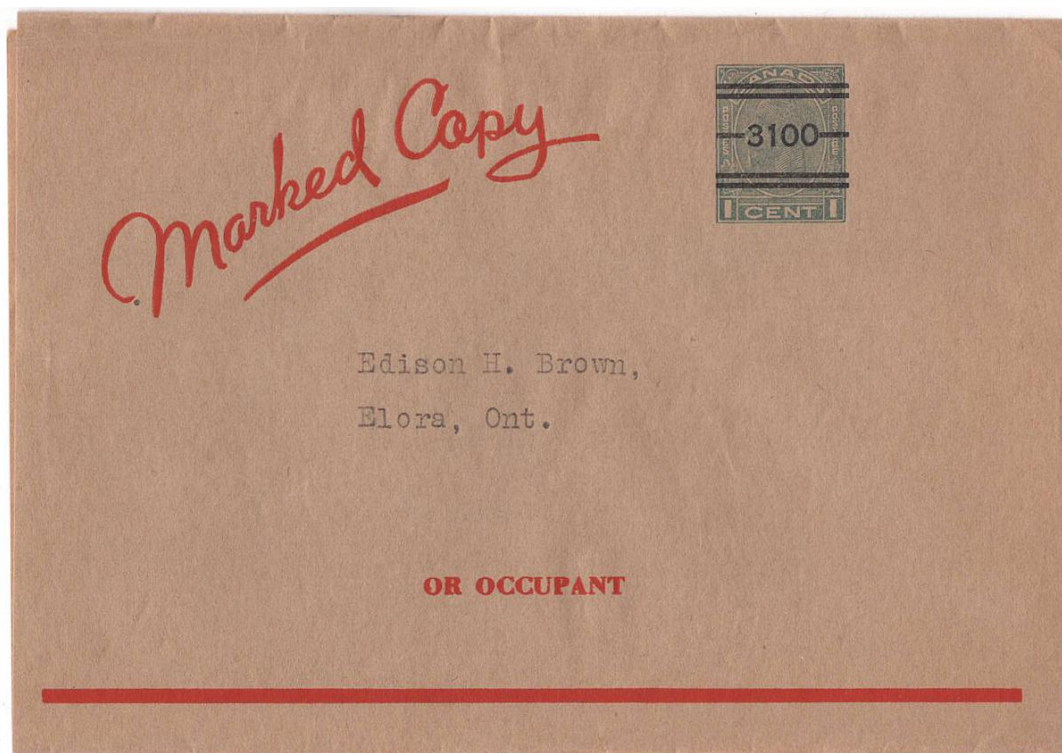
Item 650-49 – **Tractor illustrated registered cover** – 1929, 5c Historical (2), 2c Scroll issue tied by Winnipeg Orb cancel on Canada Tractor & Equipment Co. advertising cover, paying the 12c registered letter rate to Illinois (b/s). A pretty franking on a visually appealing tractor-themed advertising cover. \$50.00



Item 650-50 – **Group of E3 imperforated pairs** - 1927, group of five imperforate mint pairs of the 1927 20¢ Special Delivery E3 Confederation Issue, comprising: horizontal pair with sheet margin at bottom and cutting arrow at lower right, NH, lightly hinged in margin only (not affecting stamps), horizontal pair, NH, with sheet margin at left showing part of plate inscription, lower right sheet corner horizontal pair, NH, horizontal pair LH, upper right sheet corner vertical pair, NH. 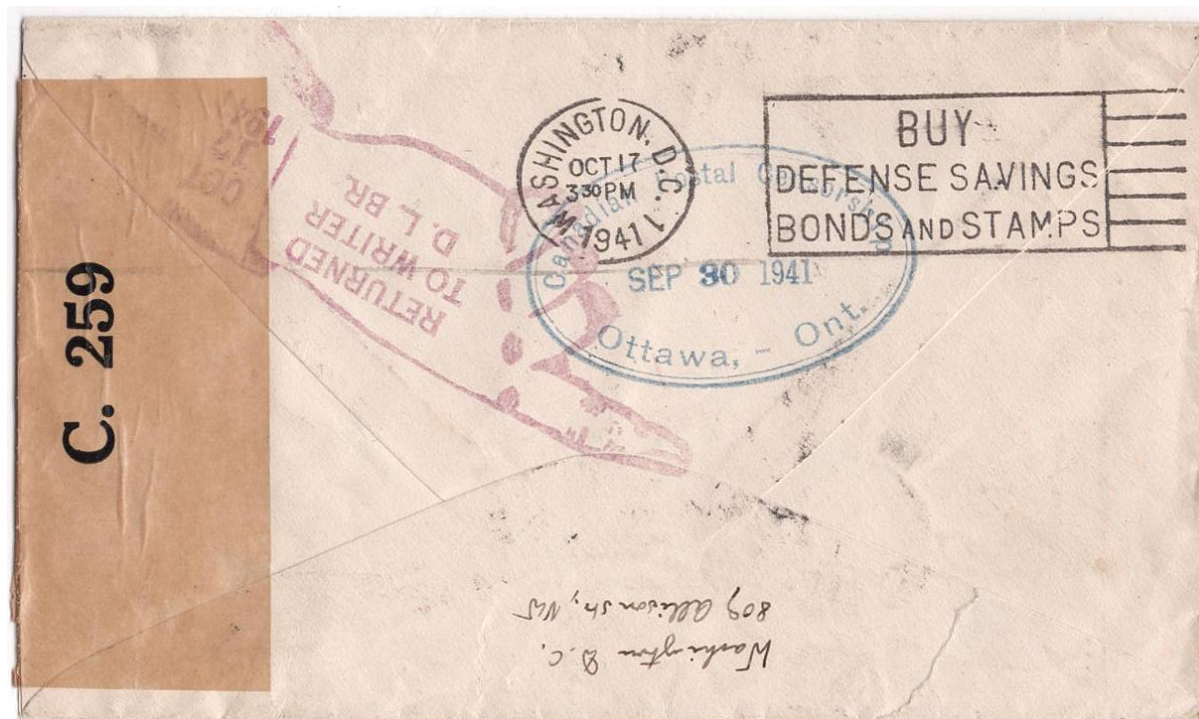
Item 650-53 – **Ottawa drop letter redirected to New York** – 1934, 2¢ Medallion tied by Ottawa machine cancel on cover paying the 2¢ drop letter rate. Redirected to Troy, New York, where 1¢ postage due was charged to meet the 3¢ U.S. single rate, paid with a 1¢ U.S. precancelled due stamp. \$25.00 **SOLD**



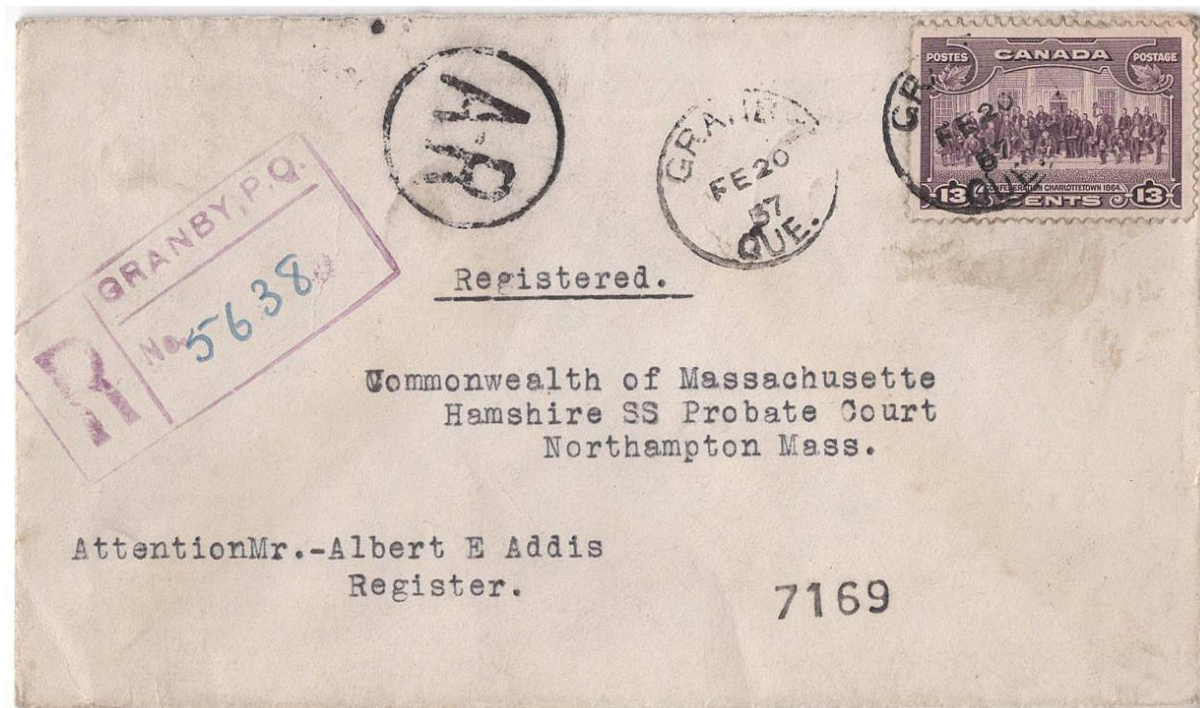
Item 650-54 – **Burford's Transport advertising** – 1933, 3¢ Medallion tied by Picton Ont machine cancel on Burford's Transport advertising cover paying the 3¢ letter rate to Hamilton. \$45.00 **SOLD**



Item 650-55 – **Cook with Hydro** – 1936, 2¢ Pictorial coil tied by London, Ont. machine cancel on Public Utilities Commission cover promoting hydro services and electrical appliances, with illustrated McClary range, paying 2¢ drop letter rate. \$25.00



Item 650-56 – Vancouver to Sweden – mail service suspended (No Service) – 1941, 2¢ Confederation and 3¢ Ottawa Conference tied by Vancouver cds on censored cover paying 5¢ UPU letter rate to Stockholm, Sweden. Service suspended due to war; cover returned to sender via Ottawa with “No Service” marking and oval Canadian Postal Censorship handstamp in matching blue. The return address was in Washington, D.C., and the cover was redirected there (b/s). An interesting wartime detour cover. \$200.00 **SOLD**

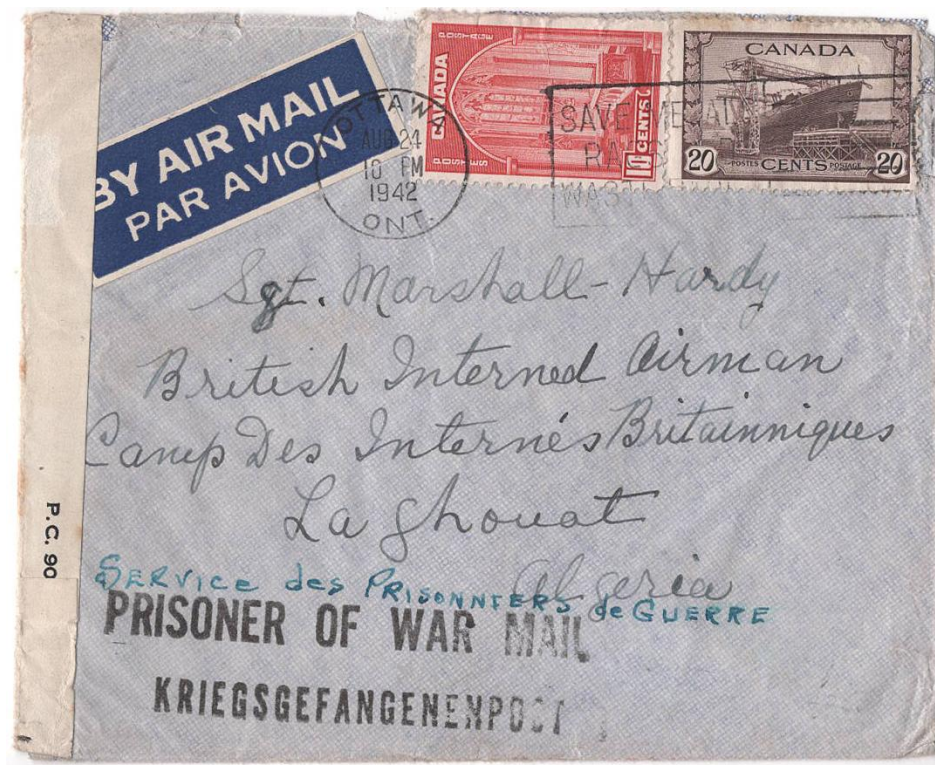
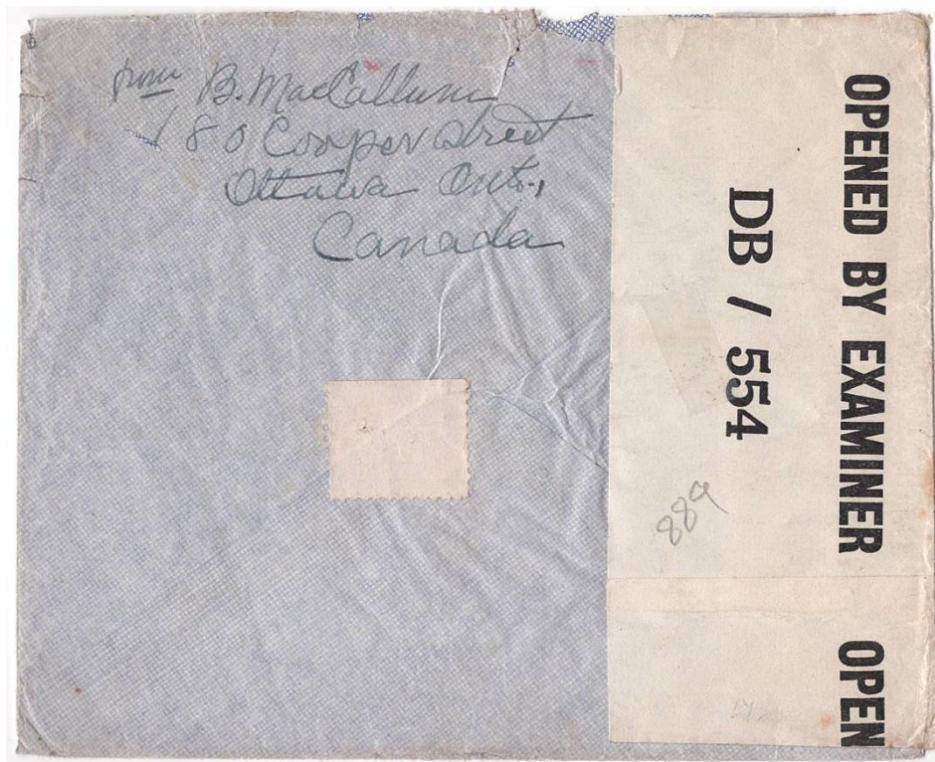

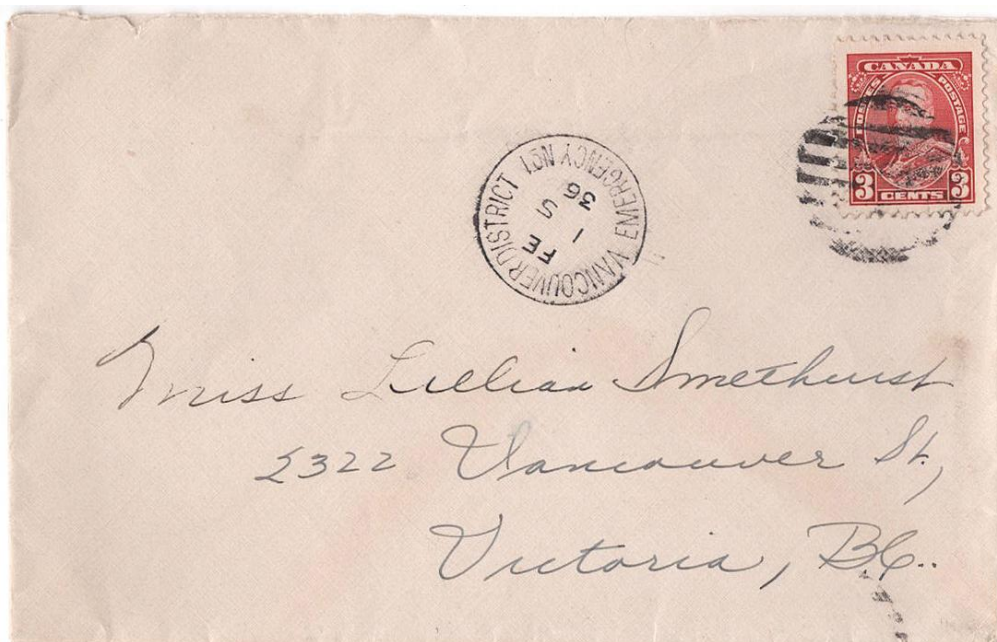
The HQ Squadron was stationed in England during its formation and training phase. A 1942 archival reference confirms its presence there.

The regiment later deployed to Northwest Europe as part of the British Liberation Army (BLA), landing in Normandy on D-Day (June 6, 1944) and advancing through France, Belgium, the Netherlands, and into Germany.

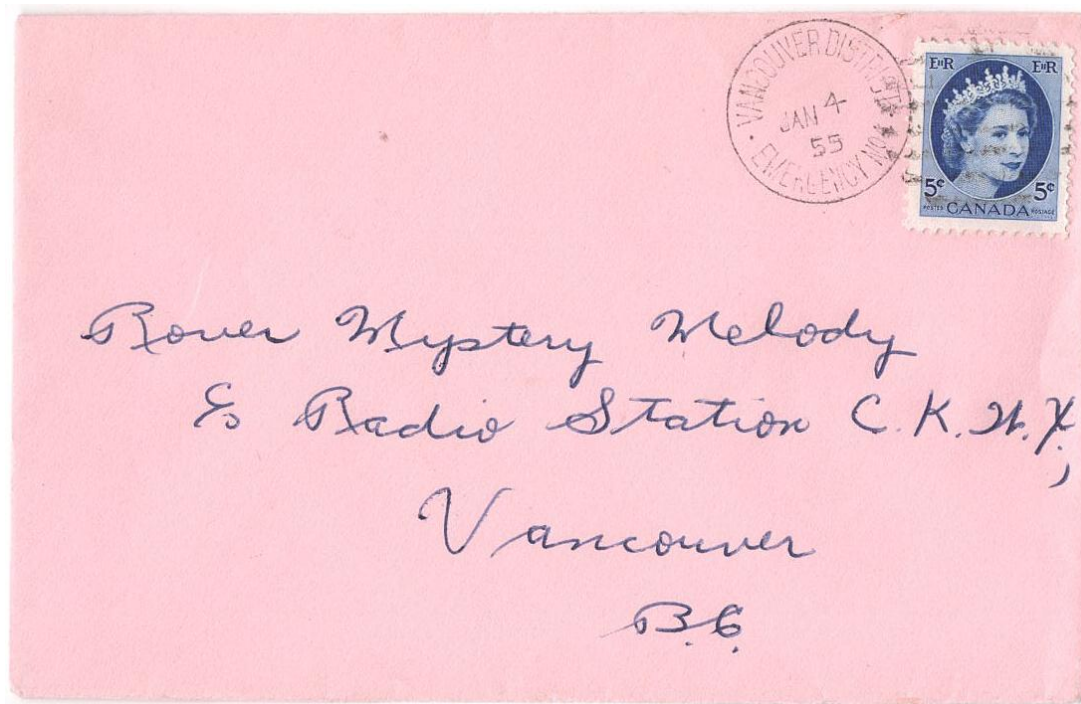

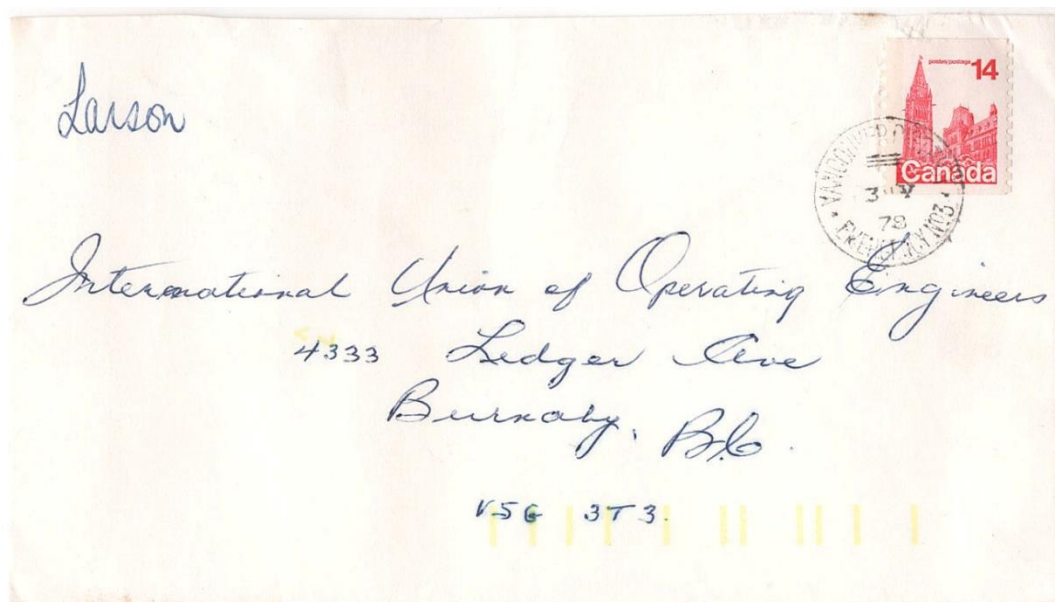

This emergency dater, unrelated to RPO service, was likely pressed into use following damage, loss, or theft of the regular hammer and possibly used by a Military Post Office elsewhere in the province. A scarce and desirable example of the hammer No. 4. \$50.00



Item 650-64 – **Vancouver District Emergency No.4** – 1978, 14¢ Parliament coil tied by Vancouver District Emergency No. 3 cds on cover 14¢ letter rate to Burnaby. This emergency dater is also unrelated to RPO service, was likely pressed into use following damage, loss, or theft of the regular hammer. A nice No. 3 strike. \$50.00

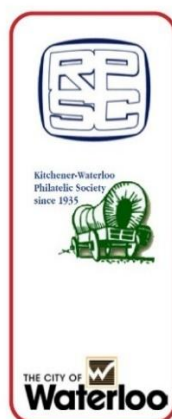
